California State Preschool Program (CSPP) Half Day

Our State Preschool operates on an 11 month calendar. We have 30 classes with one 3 hour morning session and a 3 hour afternoon session. Priority is given to all income eligible four year olds and then all three year olds. Except for CPS children the family's adjusted monthly income cannot exceed the income ceiling established by CDE at the time of enrollment. No need criteria and no fees are charged for half day program. Six hours of parent participation per month is a program expectation.

Preschool classes begin in August and end in June; total days of operation are 178 days.

California Care (CCTR)

California Care is a year round program that opens at 7:30 AM and closes at 5:30 PM. CCTR has same income and need criteria as CSPP full day; however this program serves children ages 2 and up. Full day fees are assessed and depending on family size and income there may be a fee.

CSPP Full Day Preschool

Full day preschool is a year round program that operates from 7:30 AM to 5:30 PM. Enrollment priority is based on income and need. Income eligible families are also required to demonstrate a need, which includes: employment, seeking employment, education or training, homeless and seeking housing. A fee may be charged based on income. Fees are assessed only for the portion of the day that exceeds the 3 hour preschool core program of 9:00 AM to 12:00 PM for the CPRE 178 days of operation. Full time fees may be assessed during the non-operational days of CSPP half day program.
