Local Control and Accountability Plan and Annual Update Template

Expelled pupils (for county offices of education only): coordination of instruction of expelled pupils pursuant to Education Code section 48926. (Priority 9)

Foster youth (for county offices of education only): coordination of services, including working with the county child welfare agency to share information, responding to the needs of the juvenile court system, and ensuring transfer of health and education records. (Priority 10)

Pupil achievement: performance on standardized tests, score on Academic Performance Index, share of pupils that are college and career ready, share of English learners that become English proficient, English learner reclassification rate, share of pupils that pass Advanced Placement exams with 3 or higher, share of pupils determined prepared for college by the Early Assessment Program. (Priority 4)

Other pupil outcomes: *pupil outcomes in the subject areas described in Education Code section 51210 and subdivisions (a) to (i), inclusive, of Education Code section 51220, as applicable. (Priority 8)*

1. The Blake Elementary School District's increase in funding from LCFF based on supplemental and concentration grants is \$14,179.

2. The district is expending its supplemental grant funds as determined by district goals, outlined in sections 2 and 3 of this document.

3. District-wide justifications: 87% of the Blake Elementary School District's pupils are identified as either low income or English learner and the district has determined that the most effective use of its LCFF supplemental and concentration grant funds would be to enhance intervention services for all students. Blake ESD is a one-school district.

- A portion of the funding will be used to support the cost of an instructional aide, which will serve to enhance the current adult/student ratio. Given the multi-grade setting of this tiny district, with all students in one room, the help of an instructional aide is imperative.

- A portion of the funding will be used to increase instructional time for the current music program, which will be conducted by a 2-hour per week instructor. Music instruction has shown to be an asset with respect to teaching English learners.

D. 1. Given the minimum proportionality percentage (MPP) calculation, the Blake Elementary School District will increase or improve services by

10.70%.

2. Services for low income and English learners will be improved as identified in this document in sections 3A and 3B. Software appropriate for English learners will be purchased in order to enhance instruction. English learners will be provided electronic tablets for take-home use.
