## Flow Chart and Contact Protocol for Department of Human Services to Education Providers

### **The role of the child's social worker is to:**

1. Obtain Release of Information from the educational rights holder.
2. If the parent/guardian is the holder of educational rights and is unavailable to make decisions for the child, the social worker shall work with the court to determine if the parent's/guardian's educational rights shall be limited.
3. Provide a copy of available records on the child's educational, emotional and social history to the child's caretaker.
4. Notify the LEA if the child's transfer and/ or incoming transfer.
5. Communicate regularly with the child's school and teacher.
6. Attend scheduled IEP meetings for the child.

### **Contact Protocol for the Department of Human Services.**

When a LEA requires information about a child placed in foster care, the LEA shall use the following contact protocol:

1. Contact the child's primary County Social Worker. To obtain a Social Worker's phone number contact the Social Service Lobby Receptionist at 631-6422
2. Contact the County Social Workers' Supervisor.
