Items not appearing on the agenda cannot, by law, be the subject of board action.



### 5.0 REPORT OF COUNTY BOARD OF TRUSTEES MEMBERS

- 5.1 Trustee Eskew shared that although she missed last month's meeting, she watched it online and received a phone call afterward informing her that the county board's resolution in support of AB 84 helped influence 23 people to change their stance. She expressed pride in the resolution being read and considered, calling it a meaningful achievement. Trustee Eskew also encouraged the public to stay informed and engaged in educational issues, emphasizing the importance of speaking up, signing petitions, and contacting legislators. She concluded by underscoring the shared responsibility to protect children and the power of collective advocacy.
- 5.2 Trustee Cisneros shared that she attended a Blessings Tea hosted by the Bakersfield Pregnancy Center on June 27, 2025, highlighting it as a meaningful event for those in ministry and public service. She mentioned Otilia Curiel from the center expressed interest in presenting an informational item at the August meeting about the center's services for teens and students.

Trustee Cisneros also stated she was looking forward to attending the Community Learning Center Junior High Summer Program Showcase and mentioned a new Christian library in Bakersfield at 3671 Rosedale Highway. The library will host an event on August 16, 2025, called "See You at the Library," featuring Kirk Cameron and Brave Books, which promote patriotic and moral values. She briefly updated the board that AB 84 is still under consideration in the assembly and referenced a recent U.S. Supreme Court decision in *Mahmoud v. Taylor* (June 27, 2025), affirming parents' rights to opt their children out of LGBTQ+ materials in public schools based on religious beliefs.

- 5.3 Trustee Robinson reflected on a recent event at Hodels featuring Sonya Shaw, a candidate for California State Superintendent of Public Instruction, emphasizing her opposition to AB 84 and AB 89. He praised the event for highlighting the ongoing challenges in California's education system. He also mentioned attending the New California State Convention, where representatives from across the state discussed educational reform and opposition to current state-level control by organizations like the California Teachers Association and the California Department of Education. Trustee Robinson expressed strong support for restoring "normalcy" in education by eliminating confusion and what he described as the undue influence of powerful organizations. He encouraged open dialogue about AB 84, urging people to stay informed and engaged.
- Trustee Little shared legislative updates and voiced support for several bills aimed at increasing school safety, transparency, and parental rights. She highlighted that AB 84 will be heard as a special order by the Senate Education Committee on July 16, 2025, with potential for further Assembly review if amended. She supported SB 848 (enhanced safeguards against child abuse in schools), SB 339 (greater transparency in interdistrict transfer decisions), and AB 844 (protection of sex-segregated spaces in schools). She also supported a bill allowing parents to opt their children out of specific instructional content. Trustee Little strongly opposed AB 495, which she described as dangerous, warning it could allow individuals to claim guardianship of children with minimal oversight, effectively enabling "legal kidnapping."

### 6.0 REPORT OF COUNTY SUPERINTENDENT

Dr. Mendiburu provided updates on recent budget changes, highlighting a \$1.9 billion deferral in funding for the 2025-26 school year that will be paid out in 2026-27, helping districts stay financially whole while easing the state's cash flow. The budget now includes a full 2.3% Cost of Living Adjustment (COLA) for all districts and county offices. Additionally, \$1.7 billion has been restored to the discretionary block grant to assist districts, particularly with costs related to ongoing sexual abuse litigation. Changes to the Expanded Opportunities Program (EOP) were noted, lowering the unduplicated student percentage threshold from 75% to 55% for funding eligibility and increasing the minimum grant to \$100,000 to better support small districts. He also updated the board on CAAT Charter's leadership: Greg West, former Administrator of the Kern Integrated Data System, started as CEO on July 1, 2025, while Joanna Kendrick continues to focus on curriculum. Both report directly to the board president, and ongoing oversight is in progress.

#### VII. New Business

#### A. Needs Assessment Results

Michelle explained that ELACs are charged with conducting a parent survey to gather information from the parents of English learners about ELD, the program that their children are involved in while with us, etc. and that the most effective means of doing this over the years has been to embed our needs assessment into the LCAP survey. In the survey, EL students and parents and our staff respond to three items and are given an opportunity to provide suggestions on how to improve our EL

program. She then shared the responses to the survey. Michelle also asked if there were other questions that anyone felt also should be asked, but there were no suggestions.

### B. 2025-26 Local Control and Accountability Plan (LCAP)

Michelle shared that the draft of next year's LCAP was shared at the advisory committee meeting that the ELACs were invited to on April 11 and that there was a nice turnout from ELAC members. The most significant items relative to the EL program are the three Designated ELD teachers who will support North Kern, CLC and Tech, and Central and Redwood, and continued planning/modeling for the ELD teams at each of these sites, as well.

#### C. Parent Engagement Funds

Michelle shared that the program has about \$13,500 to spend on activities that aim to increase our parent engagement. Currently, these funds are spent on Back to School Nights/Open Houses and the LCAP Town Hall meetings. Michelle asked if there were other uses that the attendees would like to suggest. Patrick asked if the money rolls over if it's not spent and Michelle said that she would ask Molly and get back to him with the answer. Patrick went on to suggest that some of the money go to support the new Wellness Center and/or to some sort of recognition for parents who attend Back to School Nights, parenting classes, parent-teacher conferences, etc. Nicole also suggested that we tie parent engagement to attendance by rewarding parents for students who have good attendance. Michelle said that she would share all of these ideas with Molly.

#### D. Consolidated Application

Michelle explained that we will soon be applying for federal funding through what is called the Consolidated Application, or ConApp. This is an annual process. She said that we will be applying for the following:

- Title I, Parts A and D. Title I funds will be used primarily to cover the salaries and benefits of social workers and various teachers and paraprofessionals who provide intervention and support for students.
- Title II. These funds address teacher quality and are used for trainings and conferences.
- Title IV. There is a lot of flexibility with Title IV and these funds will be added to those we receive from Title I.
   Jamie made a motion to apply for the funds as outlined. Mr. Crawford seconded the motion. The motion was unanimously approved.

# MEMORANDUM OF UNDERSTANDING BETWEEN

### THE KERN COUNTY OFFICE OF EDUCATION

#### AND

# RIDGECREST ELEMENTARY ACADEMY FOR LANUAGE, MUSIC AND SCIENCE

This Agreement ("Agreement," "Memorandum of Understanding" or "MOU") is executed by and between the Kern County Board of Education ("County Board") and Kern County Superintendent of Schools ("Superintendent"), collectively the Kern County Office of Education ("County"), on one hand, and the Ridgecrest Charter School ("RCS"), a California non-profit public benefit corporation that is operating the Ridgecrest Elementary Academy for Language, Music and Science (collectively "REALMS") on the other. The County and RCS shall be referred to herein as the "Parties."

### RECITALS:

- A. The Kern County Board of Education is a county board of education existing under the laws of the State of California. The Kern County Superintendent of Schools is a county superintendent existing under the laws of the State of California and serves as authorized representative of the County Board for purposes of this MOU.
- B. The County Board approved the renewal petition for Ridgecrest Elementary Academy for Language, Music, and Science ("Charter School") for a five-year term, commencing on July 1, 2025, and ending on June 30, 2030 ("Charter").
- C. The parties recognize that the laws of the State of California authorize the formation of charter schools for the purpose, among others, of developing new, innovative and more flexible ways of educating children within the public school system and improving student learning through performance-based accountability.
- D. By renewing the Charter, the County Board continued to be the authorizer of the Charter School.
- E. The Charter School shall continue operations for a term of five (5) years, from July 1, 2025, through June 30, 2030, unless the Charter is sooner revoked or the Charter School voluntarily closes in accordance with law.
- F. Written modification of this Agreement may be made by mutual agreement as set forth below.

NOW, THEREFORE, in consideration of the promises and the mutual covenants and agreements herein set forth, RCS and the County do hereby agree as follows:

#### AGREEMENTS:

### I. TERM AND RENEWAL

- A. The term of this Agreement shall be coterminous with the term of the Charter and shall be effective upon full execution by the Parties and upon approval or ratification of the County Board and RCS's Board of Directors ("RCS' Board"), respectively, and shall remain in place until June 30, 2030 ("Term"), unless sooner terminated in accordance with the provision included herein.
- B. Any modification of this Agreement must be in writing and executed by duly authorized representatives of both parties specifically indicating the intent of the Parties to modify this MOU.
- C. The duly authorized representative of the Charter School is the RCS Board of Directors or its designee. For purposes of amendment of this MOU, the Board of Directors is required to take action.
- D. The duly authorized representatives of the County are the County Board and the Superintendent, or his or her designee(s). For purposes of amendment of this MOU, the Superintendent is required to take action as authorized representative of the County.
- E. This MOU will continue in effect until mutually modified in writing by the Parties, except that the MOU shall terminate upon the expiration, rescission, or revocation of the charter. Amendments to this MOU may be made upon written agreement of the Parties.
- F. To the extent that this Agreement is inconsistent with any of the terms of the charter, this MOU shall supersede the terms of the charter unless specifically noted otherwise herein. Both parties shall meet to amend the Agreement or the charter to achieve consistency as necessary.

### II. PURPOSE OF MEMORANDUM OF UNDERSTANDING

The State of California enacted the Charter Schools Act of 1992 ("the Act") authorizing the creation of charter schools with the intent that the schools improve student learning through a variety of means, including increased learning opportunities, innovative teaching methods, expanded choice for parents, and performance-based accountability.

The Act allows the County Board to authorize charter schools under specified circumstances. The County Board has authorized this charter pursuant to the Act, and by doing so, becomes the authorizing agency of the Charter School. The County has delegated to the Superintendent its obligations to oversee the charter under the terms

of this MOU and the charter, and applicable laws and regulations, reserving the right and authority, under its obligations, to modify any decision made by the Superintendent.

The fundamental interest of the County is - on a continuing basis - to be reasonably assured that the Charter School is:

- Implementing the provisions of the charter as approved.
- Obeying all requirements of federal, state, and local laws that apply to the Charter School.
- Being operated prudently in all respects.
- Providing a sound education to all of its students.

The Superintendent will report periodically to the County Board regarding its delegated oversight of the Charter School.

The County recognizes that there are a limited number of matters related to the operation of the Charter School and to the effective oversight of the Charter School that go beyond the provisions included in the charter. The County also acknowledges that the general operation of the charter is appropriately carried out by the RCS's Board of Directors, Charter School's administrators, faculty, and staff. This MOU is intended to address those matters that have not been covered in the charter and to provide guidance on the oversight policies and procedures of the County, as carried out by the Superintendent. Further, this MOU is intended to outline the Parties' agreements governing their respective fiscal and administrative responsibilities and their legal relationships.

#### DESIGNATION OF SCHOOL III.

- REALMS is to be operated by RCS, a non-profit public benefit corporation pursuant to California law and together they shall be responsible for all Α. functions of the Charter School in accordance with the terms and conditions set forth in this Agreement and its charter.
- Grade Levels: The Charter School is approved to serve students in grades TK-6. В.

#### **FUNDING** IV.

- The Charter School shall receive funding under the charter school Α. funding model as established by the Education Code, including:
  - 1. General-purpose entitlement computed by the local control funding formula pursuant to Education Code Section 42238.02, as implemented by Education Code Section 42238.03.

- General-purpose funding that consists of state aid, local property taxes, and
  other revenues applied toward a school district's local control funding formula,
  pursuant to Education Code Section 42238.02, as implemented by Education
  Code Section 42238.03.
- 3. The Charter School is entitled to lottery funds pursuant to Education Code Section 47638.
- 4. Any additional funds negotiated by the Charter School in accordance with Education Code Section 47636.
- 5. The Charter School may be eligible for federal funding including, but not limited to Title I, II, III, IV and VII, based on the qualification of the Charter School's students for such funding. It is the Charter School's obligation to apply for this funding on its own.
- B. In addition to the block grant funding specified above, the parties recognize the authority of the Charter School to pursue additional sources of funding.
- C. The County has no obligation to apply for additional sources of funding for the Charter School. However, if the County applies for additional sources of funding in the form of grants and/or categorical funding at the request of and for the benefit of the Charter School, the County shall receive 1% of such funds or as required by the specific funding source.
- D. The Charter School shall cooperate fully with the County in any application made by the County on behalf of the Charter School.
- E. The Charter School agrees to comply with all regulations related to expenditures and receipt of such funds.
- F. The Charter School has elected to receive funding from the State directly, pursuant to Education Code Section 47651.
- G. With each annual submission of a budget to the County Superintendent for review, the Charter School will provide written assurance of funding from identified sources, including state funding, sufficient to cover all proposed expenditures.
- H. The Charter School acknowledges and agrees to adhere to the terms and conditions of the board approved Fiscal Stabilization Plan as outlined in Exhibit A attached hereto and incorporated by reference. This plan outlines the actions, strategies and measures the Charter School will implement to ensure its long-term fiscal stability.

- Charter School agrees to maintain a minimum reserve fund of 5%of its total annual operating budget.
- J. In the event that the Charter School fails to comply with the terms of the Fiscal Stabilization Plan or fails to maintain the required minimum reserve fund, the Charter School agrees to voluntarily close the school and terminate the Charter by the end of the school year.

### V. LEGAL RELATIONSHIP

- A. The parties recognize that REALMS is a separate legal entity. REALMS shall be operated by RCS, a non-profit public benefit corporation under Education Code Section 47604. As such, in accordance with Education Code Section 47604(d), if the County complies with all oversight responsibilities required by law, the County Board shall not be liable for the debts or obligations of REALMS or for claims arising from the performance of acts, errors, or omissions by RCS or the Charter School.
- B. The County Board shall have the right to appoint a representative to the RCS Board of Directors with full voting rights.
- C. The Charter School shall work with families who are migrant workers to ensure a space is held for any federally-identified migrant student who must leave the Charter School to return in the same school year for purposes of a parent or parents' migrant occupation.
- D. An enrollment database will be developed and maintained by the Charter School, which identifies all students enrolled in the Charter School by grade level including students who do not complete the school year for any reason, students who are expelled or otherwise removed, and students who transfer during or in between school years. The database will be available to the Superintendent on request.
- E. The Charter School shall hold harmless, defend, and indemnify the County Board and the Superintendent, their officers and employees, from every liability, claim, or demand which may be made by reason of (1) any injury to volunteers; and (2) any injury to person or property sustained by any person, firm, or corporation caused by any act, neglect, default, or omission of the Charter School, its officers, employees or agents. In cases of such liabilities, claims, or demands, the Charter School at its own expense and risk shall defend all legal proceedings which may be brought against it and/or the County Board or the Superintendent or their officers and employees, and satisfy any resulting judgments up to the required amounts that may be rendered against any of them.

### VI. COUNTY OVERSIGHT/SERVICES

- A. In accordance with Education Code Section 47613, the County may charge for the actual costs of supervisorial oversight not to exceed one percent (1%) of the revenue of the Charter School and to be increased to three percent (3%) of the revenue of the Charter School if the Charter School is able to obtain substantially rent free facilities from the County. "Revenue" is defined in accordance with Education Code Section 47613(f).
- B. The Charter School and the County agree that "supervisorial oversight," as used in Education Code Sections 47613 and 47604.32, shall include the following:
  - All activities related to the charter revocation and renewal processes as described in Section 47607.
  - Activities related to monitoring the performance and compliance of the Charter School with respect to the terms of its Charter, related agreements including this Memorandum of Understanding, development and implementation of the Charter School's local control and accountability plan ("LCAP"), and all applicable laws.
  - Review and timely response to the Charter School's Annual Independent Fiscal and Performance Audit.
  - Identify at least one staff member as a contact person for the Charter School.
  - Visit the Charter School at least annually.
  - Monitor the fiscal condition of the Charter School, which includes reviewing average daily attendance ("ADA"), budget reports, financial audits, STRS/PERS reporting, LCAP, governance board packets, insurance requirements, and reserve requirements.
  - Provide timely notification to the California Department of Education if any of the following circumstances occur:

A renewal of the charter is granted or denied. The charter is revoked.

The Charter School will cease operation for any reason.

C. To the extent that the County may be required to submit financial forms on behalf of the Charter School, the Charter School is required to maintain official financial records on the County financial system. The County agrees to provide the Charter School with written notification of any applicable processes that may be required. The Charter School agrees to follow processing schedules and specified County business office procedures. The

authorized representative of the County shall communicate the procedures to the Charter School.

# VII. EVALUATION OF EDUCATIONAL PROGRAMS/CONFORMANCE TO CHARTER

- A. The fundamental oversight and monitoring of the Charter School shall be in conformance with County policy, state and federal law and the terms of the approved charter.
- B. The Superintendent will conduct at least one site visit annually in order to assess the Charter School's progress in governance and organizational management, educational performance, fiscal operations, and fulfillment of the terms of the charter, this MOU, and any associated agreements. The focus of the review will be on teaching and learning. The County-approved Charter School Evaluation Form and the Document Review Checklist describe the evidence and documentation that will be reviewed and evaluated each year.

The site visit may include review of the facility, review of records maintained by the Charter School, interviews with the Superintendent of the Charter School, staff, and parents, and observation of instruction in the classroom. The evaluations for each year will be taken into consideration for renewal at the end of the term of the charter. Any deficiencies will be reviewed with the Charter School administration.

The Superintendent reserves the right to make unannounced visits to the Charter School.

- C. Changes to the charter deemed to be material revisions may not be made without County consideration and County Board approval. Amendments to the charter considered to be material revisions include, but are not limited to, the following:
  - Substantial changes to the educational program (including the addition or deletion of an educational program), mission, or vision.
  - Changing to (or adding) a non-classroom-based program, if originally approved as a classroom-based program.
  - Proposed changes in enrollment that differ by more than 20 percent
     +/- of the enrollment originally projected in the charter, or as approved by the County in a subsequently revised charter.
  - Addition or deletion of grades or grade levels to be served.
  - Expulsion or removal offenses/process.
  - Changing the location of facilities and/or adding new sites.
  - Admissions preferences.
  - Governance structure.

### VIII. SPECIAL PROGRAM/SERVICES AND/OR ACTIVITIES/SPORTS

A. In the event that either party to this MOU wishes to have its students and or staff participate in a program/service/activity offered by the other party, advance approval and arrangements must be made. It is fully recognized that expenses for such participation may be charged. Such arrangements must be made with the appropriate site administration in advance and confirmed in writing.

### IX. FERPA: FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT

The County hereby designates employees of the Charter School as having a legitimate educational interest such that they are entitled to access to education records under 20 U.S.C. 1232g, the Family Educational Rights and Privacy Act ("FERPA") and California Education Code Section 49076(b)(6) as to County pupils who are enrolled in the Charter School. The Charter School hereby designates the employees of the County Board and Superintendent as having a legitimate educational interest such that they are entitled to access under FERPA to the education records of pupils who are enrolled in the Charter School. The Charter School, its officers and employees shall comply with FERPA at all times.

### X. SPECIFIC REQUIREMENTS

- The Charter School will develop a systematic and strategic plan for implementing its many and varied new instructional and intervention initiatives. Professional development must be provided with a continuum of options such as workshop, coaching support, in-classroom modeling and observation of others with expertise in that specific initiative. This may require the Charter School to contract for services of those with expertise in specific areas or hire additional staff such as a literacy coach.
- A teacher observation form will be used to monitor instruction on a daily basis and provide feedback and coaching support to teachers, as needed.
- The Charter School will define its instructional day and align its published bell/daily schedule with its master schedule for instruction and the Parent Student Handbook.
- The Charter School will identify and incorporate some form of literacy assessment (DIEBELS, for example) into its K-3 programs that will be used as a systematic tool for ongoing monitoring and reporting of student growth.
- The Charter School will define when Designated ELD will take place during ELA/reading instructional time, and will define what instrument will be used to monitor progress throughout the year for language proficiency of EL students.
- The Charter School will ensure that its identification and reclassification of

English Learners aligns with Education Code requirements.

- The Charter School will provide SELPA Assurances and will ensure that its program to serve Students with Disabilities is fully compliant.
- The Charter School Board will ensure that parents who serve on the board represent the majority of parents of the school.

### XI. LEGAL SERVICES

The Charter School will be responsible for procuring its own legal counsel and the costs of such service.

### XII. SEVERABILITY

The terms of this MOU are severable. In the event that any of the provisions are determined to be unenforceable or invalid for any reason, the remainder of the MOU, and the charter, shall remain in effect, unless mutually agreed otherwise by the Superintendent and the Charter School. The Superintendent and the Charter School agree to meet to discuss and resolve any issues or differences relating to the provisions of the MOU in a timely, good faith fashion.

### XIV. ENTIRE AGREEMENT

This Agreement contains the entire agreement of the parties with respect to the matters covered hereby, and supersedes any oral or written understandings or agreements between the parties with respect to the subject matter of this agreement. No person or party is authorized to make any representations or warranties except as set forth herein, and no agreement, statement, representation or promise by any party hereto which is not contained herein shall be valid or binding. The undersigned

acknowledges that she/he has not relied upon any warranties, representations, statements or promises by any of the parties herein or any of their agents or consultants except as may be expressly set forth in this Agreement. The parties further recognize that this Agreement shall only be modified in writing by mutual agreement of the parties.

### RESOLUTION OF THE KERN COUNTY BOARD OF EDUCATION

This Proclamation designates September 2025 as School Attendance Awareness Month, and would encourage public officials, educators, and community members throughout Kern County to observe the month with appropriate activities and programs.

WHEREAS, good school attendance is essential to pupil achievement and graduation, and systemic approaches are needed to reduce chronic absenteeism rates in Kern County, with a focus starting as early as pre-kindergarten; and

WHEREAS, chronic absence, missing 10 percent or more of school, which can be just two or three days a month, for any reason, including both excused and unexcused absences, is a proven predictor of academic difficulty; and

WHEREAS, a pupil's chronic absence is a predictor of below-grade-level reading proficiency by the third grade and course failure and eventual dropout later in that pupil's career, and chronic absence thereby weakens our communities and our local economies; and

WHEREAS, the impact of chronic absence affects low-income pupils and children of color particularly hard if they do not have the resources to make up for lost time in the classroom. Low-income pupils and children of color are more likely to face systemic barriers to getting to school, such as unreliable transportation, lack of access to health care, unstable or unaffordable housing, and even unfair disciplinary policies; and

WHEREAS, chronic absence exacerbates the achievement gap that separates low-income pupils from their peers, since pupils from low-income families are both more likely to be chronically absent and more likely to be affected academically by missing school. Absenteeism also undermines efforts to improve struggling schools, since it is hard to measure improvement in classroom instruction if pupils are not in class to benefit from the improvement efforts; and

WHEREAS, improving school attendance and reducing chronic absence take commitment, collaboration, and tailored approaches to address particular challenges and strengths in each community; and

WHEREAS, all pupils, even those who show up regularly, are affected by chronic absence because teachers must spend time reviewing for pupils who missed lessons; and

WHEREAS, school attendance can be improved, and chronic absence significantly reduced, when schools, parents, and communities work together to monitor and promote good attendance and address hurdles that keep children from getting to school; now, therefore, be it

**RESOLVED** by the Kern County Board of Education thereof concurring, that the Board designate September 2025 as School Attendance Awareness Month in Kern County, and encourage public officials, educators, and community members to observe the month with appropriate activities and programs.

WHEREAS, the Semitropic Elementary School District ("District"), is within the geographical boundaries of the Kern County Superintendent of Schools (KCSOS"), and the Kern County Board of Education, ("KCBOE"), and has requested a temporary "bridge loan" in the amount of \$500,000.00 from KCSOS, in the form of a line of credit, in order to meet its financial obligations for the 2025-26 fiscal year; and

WHEREAS, the KCSOS Fiscal Support Division has verified and concurs with the District's negative cash projections and agrees that a loan in the form of a line of credit of up to \$500,000.00 will likely be necessary to maintain the District's solvency; and

WHEREAS, Education Code ("EC") section 42622 provides that the county superintendent of schools, with the approval of the county board of education, may make an apportionment to a school district from the county school service fund ("Fund"). The apportionment must be made conditional upon the repayment to Fund during the next succeeding fiscal year of the amount apportioned to the school district. Additionally, during the next succeeding fiscal year, such school district shall transfer the amount of the apportionment from its general fund, back to Fund with interest; and

WHEREAS, the KCSOS hereby seeks approval from the KCBOE to make such a loan to the District; and

WHEREAS, repayment shall be required during FY 2026-27 in conformance with EC section 42622; and

WHEREAS, repayment is to include a daily interest rate that is equivalent to the rate that would otherwise be accrued by funds held in the Kern County Treasury Pooled Investment Fund; and

WHEREAS, the loan may be made on other and additional terms and conditions deemed advisable by KCSOS and agreed to by the District; and

WHEREAS, upon approval of the loan by the KCBOE, the District agrees to repay all funds and the accrued interest, on or prior to June 30, 2027.
