CUSTODIAN I

DEFINITION

Under supervision, to maintain an assigned facility, group of buildings, or office space in a clean, orderly, and secure manner following a predetermined schedule;

to do other related work as required.

EXAMPLES OF DUTIES

Sweep, mop, strip, wax, and seal floors;

vacuum rugs and carpets;

dust, wash, and polish furniture and woodwork;

empty and clean waste receptacles, including trash barrels;

clean restrooms and work areas;

wash windows and walls;

polish metalwork;

clean chalkboards;

move and arrange furniture and equipment in preparing multipurpose rooms or classrooms for special events or meetings;

replace light bulbs and lighting tubes;

clean window coverings, such as drapes and blinds;

pick up paper and other debris from grounds, walk areas, and the areas adjacent to the facilities;

sweep concrete surfaces adjacent to buildings;

perform emergency cleanup service resulting from breakage and vandalism;

may lock and unlock gates and doors;

may set security;

may perform minor maintenance tasks in keeping assigned areas safe and operational;

may occasionally perform routine grounds maintenance functions;

assist in reporting and preventing facility vandalism;

maintain equipment and supplies in proper condition;

may assist in distributing supplies and/or equipment.

QUALIFICATIONS

<u>Knowledge of</u>: Basic cleaning methods, procedures, and techniques;

cleaning materials, supplies, and equipment;

safe working methods and procedures.

<u>Ability to:</u>

Perform moderately heavy manual activities;

efficiently and effectively use cleaning materials, supplies, and equipment;

understand and carry out oral and written directions;

establish and maintain cooperative working relationships;

lift 50 pounds, climb ladders, stoop, bend, kneel, squat, crawl, stand for long periods of time, work with arms extended above body, and see and hear sufficiently to safely perform the duties listed above.

Experience:

Six (6) months of experience involved with the care and cleaning of buildings and facilities.

Education:

Completion of formal or informal education sufficient to assure the ability to read and write at the level required for successful job performance.

Conditions of employment:

Pre-employment drug testing along with a pre-employment physical is a condition of employment.

Some positions may require proof of privately owned automobile insurance and possession of a valid California Motor Vehicle operator's license which must be maintained for the duration of the assignment.

Fingerprint clearance by both the Federal Bureau of Investigation and the California Department of Justice is a condition of appointment after all other required job conditions have been met.

Must present verification of completion of Child Abuse Mandated Reporter training or obtain verification within six (6) weeks of hire and annually thereafter, as required by the California Child Abuse and Neglect Reporting Act.

This position has a probationary period of six months or 130 days, whichever is longer.
