#### PROGRAM COORDINATOR - EDUCATOR DEVELOPMENT

#### **DEFINITION**

Under direction of the Director, will oversee aspects of the assigned Department grants and programs and be the primary contact for assigned program partners.

#### **EXAMPLES OF DUTIES**

The Coordinator will develop, manage, supervise, and implement all aspects of the assigned programs;

supervise and coordinate the implementation of all components of the assigned programs including budgets, contracts, personnel, professional development, data collection, reports, evaluation, site visits, and technical assistance;

serve as the primary contact for all school districts or community-based partners participating in the assigned programs;

participate in statewide, regional, and local activities required of the assigned programs;

design, facilitate, or coordinate appropriate trainings for KCSOS employees, school districts or community-based partners participating in the assigned program(s);

oversee, design, coordinate and facilitate professional learning activities and stakeholder meetings of assigned programs ensuring standard requirements, state and local priorities, and the identified needs of program participants are met;

collaborate with district representatives from each partnering district/institution to effectively enroll, provide support and monitor the progress of each program participant.

may help with recruitment/retention of AmeriCorps Members;

create, implement, and deliver professional development for assigned program activities and goals;

maintain accurate records of work completed by program participants and other personnel hired to support program activities;

work with site personnel to monitor work and assess needs;

facilitate program evaluation and reporting;

manage and evaluate staff assigned to implement the assigned program;

Supervise and evaluate assigned classified staff;

perform other related duties as assigned.
