Key Strategies:

- Emergency food pantry and donations received from the school.
- Refer clients to 211 when in need of housing & utilities assistance.
- Geeting families to attend parent group meetings or events.
- Try to increase agency partnerships through collaboration.
- Partners with the Buttonwillow Union School District, Recreation and Park District, The Lions Club, Chamber of Commerce, The Buttonwillow Foundation, and the Senior Center, as well as the local churches and stores in the community to obtain resources for those in most need.

Community Concern: Health care needs.

Key Strategies:

- Assist clients with applying for insurance and refer to local health care and behavioral assistance agencies.
- Partner with Kern Family Health and Omni for healthcare resources and mobile health units.
- Will collaborate with Kern Family Health and bring in more assistance when needed.

Additional Comment: The Buttonwillow FRC relocated offices within the Buttonwillow Union School District campus and opened back to the public in February 2025.

Community Concern: Family Support Services and Lack of Affordable Housing

Key Strategies:

- Refer individuals to our M street Navigation program, Flood Ministries, and the Open-Door Network if families are involved. We continue to seek more resources for unhoused clients within East Kern County.
- Actively seeking partnerships with community organizations to expand services across East Kern County. Without collaboration among CAPK departments and local partners, many low-income families would face traveling over 100 miles for assistance—a significant barrier that limits access to essential services.

Community Concern: Food Insecurities

Key Strategies:

- We are assisting families in Quarter 1, by serving 2,888 individuals with Food assistance, Emergency Clothing, Baby items, utility assistance, laundry services, and many other services.
- CAPK's Food Bank provides family resource center food pantry with food baskets that are distributed to assist families and individuals within the community.

Community Concern: Medical and Mental Health Services

Key Strategies:

- Referring families to Mobile Clinics and the few medical offices in East Kern County.
- We provide bus tickets and gas cards for those families facing a medical condition which needs to be addressed sooner than later.

Additional Comment: Celebrated the ribbon cutting of our expanded East Kern Family Resource Center based in Mojave in May 2025. This expansion includes a new laundry room—a game-changer in a city with no laundromats—a classroom space to support educational programming, and extra storage for clothing, food, and essentials for local families. Also, Held a Back-Pack Drive/Night Owl Event in August.

Community Concern: Family Supportive Services In Outlying Area

Key Strategies:

- Key partnerships include behavioral health agencies, domestic violence resources, early childhood education agencies, veteran's resources, and local employment resource agencies are among the consistent resources that attend the collaborative meeting on a regular basis.
- Invite new agencies to attend meetings and provide information of supportive services available to the community.
- The housing prices and the availability of affordable rental homes has increased dramatically making it difficult for the lower income families we serve to find appropriate housing. The increased costs of housing also continue to contribute to families struggling to pay utility expenses and keep reliable transportation. The other continuing trend we have seen is the high turnover in staff at our behavioral health provider and now the change in the parent company has made it even more difficult for families to access and engage in needed mental health and substance abuse counseling services. One of the priorities of the collaborative is to make sure families/clients served are aware of the resources that are available to them.
- The increased costs of housing also continue to contribute to families struggling to pay utility expenses and keep reliable transportation. With AI taking over many of the local fast food industry jobs, the lack of basic employment opportunities has made it difficult for some people to find employment. We continue to support organizations working with families/clients that way they are aware of the resources that are available to them.

Additional Comments: IWV Collaborative meeting is a very well attended meeting in our community. We have between 25 and 35 attendees every month and the attendance are trending up recently. We are in-person only meetings and the attendance and participation continue to be good, thank you.

- Working closely with the schools to further support linking families with mental health services and continuously working with collaborative partners to enhance the healthcare service in the community.

- This year our office was not able to offer Emergency Food and Shelter assistance. However, we continue to refer families to agencies that support with resources.
- Expanding collaboration with agencies such as El Tejon School District, First 5 Kern, Chamber of Commerce, Frazier Mountain Community Church, Our Lady of the Snow Catholic Church and Pine Mountain Club P.O.A.
- The Volunteer Income Tax Assistance (VITA) program through CAPK visited Frazier Park and provided our community with free income tax assistance. These agencies along with others, such as the South Kern Family Justice Center, GBLA, and Aging and Adult Services have been able to bring their services directly to our community which has been particularly beneficial for clients who may experience transportation barriers.

Additional Comments: By actively participating in KCNC collaboratives it has allowed us to expand our mission and continue to stay current with the related issues of our collaborative.

Community Concern: Need for more low-income housing & utility assistance.

Key Strategies:

Have collaborative speakers on housing options and work with community members/landlords.

- Refer clients to 211 or the Department of Human Services Housing Unit for assistance.
- More regularly, families have reached out seeking utility assistance; however, it is also known that there is a lack of funding. FRC staff often refers families to the Home Energy Assistance Program (HEAP), but the lack of funding often leaves families struggling or needing to set up payment plans.

Community Concern: Family Support Services

Key Strategies:

- Partnered with Catholic Charities of Bakersfield to host food drives every other month, providing up to 250 bags of food at each event.
- Families often request assistance with obtaining car seats for their children, hygiene items, clothing, and support with mental health services.
- Provides office space to Medi-Cal Assistance representative who assists clients with Medi-Cal needs and office space to EDD representative who assists with unemployment benefits and/or disability insurance benefits.
- For families who face domestic violence, we connect them with the Open Door Network, who helps with filing restraining orders and accessing counseling services. Also, refer clients to the child and adult clinics at Clarvida (previously College Community Services) for behavioral health care needs.

Additional Comments: Received funding from various grants provided by Kern Health Systems Community Grant, and First 5 Kern, and the Kaiser Permanente Community Health Care Program. These grants have enabled us to assist families by providing car seats, gift cards for clothing purchases, transportation gas, and laundry services. Through California Community Schools Partnership Program grant funding, we will be expanding our food pantry in the 2025-2026 school year. We thank KCNC as well for their continued support.

This is achieved through regular partner meetings to promote collaboration, professional learning for family support staff, and FRC one-stop resource centers that link families to available services.

Support homeless and foster youth by ensuring access to essential resources. Local FRCs serve as liaisons for students, connecting families to services such as housing, food, and educational support.

Community Concern: Unemployment, job training, access to public benefits, and health services.

Key Strategies:

- Expanding access to adult education, including High School Diploma, ESL, nutrition, parent education, educational workshops, and others, as well as reducing unemployment and access to job training and employment resources and supports, as well as increasing access in the local community through co-location of services from EDD.
- Increased awareness of and access to public benefits through connecting families accessing services to available resources at local one-stop and resource provider locations. This includes the implementation of the UniteUs and BenefitsCal platforms to support families in accessing resources at local FRCs. Increasing access to health insurance and services.
- Increase in availability of services locally for families through co-location of services such as GBLA, EDD, Medi-Cal and health insurance, and others, as we invite partners to continue collaborating.

Additional Comments: The Vineland SD, LESD, and Arvin FRCs remain committed to providing needed services and resources, and we're thrilled to have a third center serving South Valley families in the Weedpatch community. We also welcome a new FRC coordinator to support collaborative activities and future accreditation efforts.

Community Concern: Family Support Services

Key Strategies:

- The collaborative meetings will target the issues of health and wellness, housing/utility assistance, education, mental health, lack of food and clothing, and basic family needs.
- Monthly meetings raise awareness of local programs and resources while fostering partnerships among schools, healthcare providers, businesses, churches, and community organizations to create a strong network of support.
- Initiatives include Parent Education Nights on topics such as parenting, mental health, and nutrition; a Resource Hub (online and on-site) connecting families to food, healthcare, housing, and utility assistance; and efforts to improve transportation for medical appointments outside Wasco.
- Housing remains a major need in our community, with a significant demand for affordable and stable housing options. Many families are currently living in shared housing situations because they cannot afford a place of their own.
- Transportation: Travel to and from medical appointments (Outside of Wasco). Connect families to MCP to get transportation assistance.

Additional Comments: We continue to work closely with partner agencies to bring those services to the families of Wasco. Community/School Events: Back to School Giveaway, Parent Education Nights (Minimum 2 per school year), TK/Kinder Readiness Enrollment Event, Coats and Cuts Winter Event (Local Barbers, Hairdressers), and District Advisory Meetings (DELAC/DAC).
