

Budget Overview for the 2023-24 School Year




This chart shows the total general purpose revenue Valley Oaks Charter School (VOCS) expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Valley Oaks Charter School (VOCS) is \$13,732,062, of which \$12,829,316 is Local Control Funding Formula (LCFF), \$862,746 is other state funds, \$40,000 is local funds, and \$0 is federal funds. Of the \$12,829,316 in LCFF Funds, \$952,745 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Valley Oaks Charter School (VOCS) was founded on respecting and valuing parent choice, allowing parents to tailor an education to fit their children's individual needs in a homeschool environment. Students at VOCS are educated one child at a time, incorporating various teaching methods. Working closely with VOCS' credentialed teachers, parent educators take the opportunity to teach lessons based on the child's academic ability and style of learning in a homeschool environment. Whether a student is a visual learner, an audio learner, and/or a kinesthetic learner, all students are expected to work to their fullest potential at Valley Oaks Charter School. To assist parent educators with this goal, VOCS provides numerous educational options and opportunities that can be individualized to each student's learning style, skill set, and academic potential. In addition, parent educators may choose to have their students participate in a variety of enrichment activities offered by the school.

VOCS' main site is located in Bakersfield, California. Additional satellite sites are located in Frazier Park, Kern River Valley, Taft, and Tehachapi. All sites are used as meeting areas for families and teachers and house the educational resources necessary to facilitate quality learning. VOCS serves approximately 1,088 Kern County students in five TK-8 programs and two High School programs, with 41% of our student population representing our LCFF unduplicated student count, including five foster youth and one homeless student. VOCS student population is made up of 55% white (599 students), 34% Hispanic (365 students), 5% Two or More Races (56 students), and 2% Asian (18 students). Additionally, the VOCS student population is made up of 39% socioeconomically disadvantaged (421 students), 12% students with disabilities (131 students), and 2% English learners (23 students), as reported in March 2023 the Kern Integrated Data System (KiDS) Dashboard.

Valley Oaks staff provides a safe and productive learning environment for all students. Our students participate in a variety of enrichment opportunities, club opportunities, and county competitions. Students may elect to participate in on-site enrichment classes and programs, which may include instruction in core academics, technology, applied and fine arts, physical education, industrial arts, and agriculture. At VOCS, club opportunities may consist of drama, dance, film, Random Acts of Kindness, Choose Your Own Adventure, Interact, and STEAM

clubs. Interested students also have an opportunity to participate in county competitions, including Battle of the Books, Bank of America Speech Contest, Oral Language, Science Fair, and Spelling Bee. VOCS also has an active student council that meets once a week to discuss student-identified school needs and student activities planned for the VOCS student body.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

After reflecting on the 2022-23 school year, reviewing Valley Oaks Charter Schools' (VOCS) accomplishments on the state and local performance indicators (California Dashboard), monitoring local self-assessment tools, and gathering educational partners' input, Valley Oaks Charter School is most proud of meeting all of the goals set on the local performance indicators (Basics - Teachers, Instructional Materials, and Facilities, Access to a Broad Course of Study, Implementation of Academic Standards, Parent Engagement, and Local Climate Survey). VOCS resumed participating in the CAASPP assessment for the first time since 2019 and the pandemic. 2022 CAASPP scores report that 46% of all students exceeded or met the standard for ELA, and 26% of all students exceeded or met the standards for Math. This is an overall increase of 5% for ELA and 4% for Math from 2019 CAASPP data.

Based on the reported results from the KiDS Essentials Dashboard, we have achieved notable success in the 2022-23 academic year. The data shows that our students have made impressive progress in both reading and math. In Fall 2022, 59% of Overall Students, 53% of SED students, and 40% of EL students had improved their reading proficiency, and by Winter 2023 those numbers held steady or improved slightly. Similarly, in math, we saw significant improvement as 55% of Overall Students, 46% of SED students, and 67% of EL students showed growth by Winter 2023, compared to Fall 2022.

Based on educational partners' input, VOCS is also incredibly proud of our staff's teamwork throughout the year, which included working together to provide a strong program for our students and families. With a new director, two new principals, seven new teachers, and one new support staff, the VOCS staff and school sites maintained a welcoming atmosphere at all school sites. VOCS resumed enrichment classes, workshops, clubs, and field trips to pre-pandemic activity, bringing back the community's feelings that VOCS was founded on. Woodshop, construction, and art classes continued allowing our students to learn about new trades. VOCS staff also established guidelines so all students have a path for college and/or career readiness based on the state metrics. VOCS implemented the new CTE opportunities for our students by providing five CTE pathways.

Throughout the school year, educational partners had opportunities to be part of decisions about VOCS through surveys, meetings, and committees. Results from the 2022-23 Annual Educational Partners Survey indicated 88% of educational partners feel valued by VOCS as important partners in our school. Additional results from the 2022-23 Annual Educational Partners Survey include: 99% agreed/strongly agreed that VOCS staff responded quickly to parent phone calls, Remind text, and/or emails; 92% felt connected to VOCS; and 94% reported that VOCS demonstrates caring, concern, and high expectations for students in an environment that honors individual differences and is conducive to learning. Additionally, survey results report that 95.7% of students feel safe at a VOCS campus; 92% feel engaged at VOCS, and 90% believe their feelings matter to VOCS teachers.

2023 Local Survey reports that 46.2% of all families participate in the VOCS Supplemental Curriculum Program, and 45.4% of VOCS parents attended one or more parent workshops, down 6.4% from 2021-2022 school year. VOCS considers this progress towards our goal, as we returned to in-person-only options after the pandemic, which we believe is the reason for the slight decline in attendance. However, local data from the last full school year prior to the pandemic, 2019, reports that 32% of VOCS parents attended one or more parent workshops. This is a 14.2% parent participation increase for our first entire school year back from the pandemic.

According to the 2023 Local Survey reports that 98.8% of VOCS educational partners say that VOCS provides students with all the textbooks and learning material, including allowing students to check out a Chromebook to use home, which 41% of all students have done. Additionally, 91% of educational partners feel that VOCS is preparing them for future college and/or career paths, and 94% feel VOCS demonstrates caring, concern and has high expectations for students in an environment that honors individual differences and is conducive to learning.

2023 annual survey of educational partners, 92% reported feeling connected to VOCS, 88% reported feeling valued as an important partner of VOCS, and 90% thought that they had opportunities to be a part of the decision at VOCS.

VOCS has taken significant steps towards achieving its LCAP goals by offering customized learning plans to students, providing them with Chromebooks, and giving them access to a range of online educational resources that support their academic progress. In addition, the school has assigned additional support staff to cater to individual student needs, further improving the quality of education offered. With valuable input from state, local, and educational partners, VOCS has identified areas of success and plans to continue focusing on two LCAP goals to create an environment of academic excellence and foster connectedness among students.

Reflections: Identified Need

VOCS acknowledges the need to continue spending our time and resources to improve student performance. CAASPP testing resumed in the 2021-2022 school year. Since VOCS is a parent-choice, parent-participation, independent/homeschool charter school, the school recognizes that consistency throughout the grade levels can vary from family to family and year to year. Valley Oaks Charter did not have any student groups that was two or more performance levels below all student performance on the CA Dashboard.

2022 CAASPP data shows that All Students (3rd-8th and 11th graders), school-wide, averaged the following results: English Language Arts (ELA) - 54% of all VOCS students did not meet standards, 63% of SED did not meeting standards, and 100% of EL students did not meet the standards. Mathematics - 74% of all VOCS students did not meet the standards, 83% of SED did not meet standards, and 100% of EL students did not meet the standard. The overall performance level for ELA and Mathematics was rated low. The overall performance levels for Graduation Rate (84.8%) and Chronic Absenteeism (7%) were rated medium, with 37.5% of EL students, and 12.2% of SED students

chronically absent. There was no 2022 report for College/Career. These indicators are found in four LCFF Priorities: Priority 1: Conditions for Learning; Priority 4: Pupil Outcomes/Pupil Achievement; Priority 7: Course Access; and Priority 8: Student Outcomes

Also, 2022 CAASPP data shows performance gaps between All Students and students with disabilities (SWD) where 73% of SWD students did not meeting the standards, while only 46% of All Students did not meet the standards in the area of mathematics. Additionally, socioeconomically disadvantaged (SED) students performed in the low level, while SWD performed in the very low performance level. Additionally, the CA School Dashboard indicates that 82.5% All Students graduated, with 79% of SED students graduating. Also, 27% of All Students met A-G completion with 12% of SED students meeting the A-G completion. Finally, the percentage of pupils who participated in and demonstrated college preparedness on EAP were ELA: 24.59% and Math: 10%, with SED students scoring 17.39% in ELA and 4.35% in Math. All of these indicators are found in four LCFF Priorities: Priority 1: Conditions for Learning; Priority 4: Pupil Outcomes/Pupil Achievement; Priority 7: Course Access; and Priority 8: Student Outcomes

Based on the reported results from the KiDS Essentials Dashboard, there are areas of need that continue to need to be addressed. Specifically, the data shows that by Winter 2023, there was no significant improvement in reading proficiency for Overall Students, SED students, and EL students from the Fall 2022 scores. Additionally, while there has been an increase in math proficiency across all groups of students, there are still notable disparities, particularly among SED students who have shown the least improvement in reading compared to other groups. These areas of need will continue to be highlighted and addressed through targeted interventions to ensure that all students are given the support they need to succeed.

As a result of the CAASPP and local data outcomes, VOCS will continue to work on improving the performance gaps by maintaining the percentage of fully-credentialed staff, strengthening grade-level standards-based instruction, targeted intervention, especially in the area of mathematics and early literacy, and purposeful enrichment supported by data analysis and a commitment to ongoing cycles of inquiry ensuring all students attain increasingly higher levels of achievement. Professional learning opportunities (Goal 1: Action 1.8) will continue to be available to all staff to provide additional support in all curricular, social, and emotional areas. By doing this, students who graduate from VOCS will be more prepared to enter a higher education and/or pursue a career path (Goal 1).

VOCS will also continue to work towards creating grade-level standard benchmarks (Goal 1: Action 1.1) so that parent educators will have the tools to ensure their student(s) is making academic progress through the school year, especially when using parent-selected curriculum materials. Extra Support Staff (Goal 1: Action 1.5) will continue to assist students needing target instruction in mathematics and ELA, prioritizing socioeconomically disadvantaged students and students with disabilities. Additionally, benchmark assessments, written and oral assessments, and STAR Renaissance testing will be used throughout the school year to assess the academic progress of VOCS students.

Additionally, educational strategies, supplemental curriculum/materials (Goal 1: Action 1.1), and technology supports (Goal 1: Action 1.2) will be continued to be investigated and purchased by VOCS to assist parent educators in implementing strategies in their homeschool environment, focusing on the areas of mathematics and ELA. Parent educator workshops (Goal 1: Action 1.8) focusing on mathematics and early literacy will be developed and delivered, providing an extra layer of support to the parent educators, especially for our students with unique needs. Also, engagement and connectedness opportunities will continue to be a top priority and want for VOCS staff, students, and families. Therefore, incentives, school improvements, and community partnerships will continue (Goal 2: Action 2.2 and 2.3).

Finally, according to staff, students, and parent educators, many of our students excelled under the guidance of our part-time counselor (Goal 2: Action 2.1), career associate (Goal 1: Action 1.4), and full-time counselor (Goal 1: Action 1.3). Based on educational partners' feedback, this additional support layer for academic planning and counseling services assisted students and families. All those positions will continue next year, along with maintaining the number of support staff at each site. As needed, support will be provided to our SED, EL and foster students (Goal 1: Action 1.6 and 1.7). Additional actions and services will be considered in subsequent years if student results remain the same.

LCAP Highlights

After analyzing our data and working closely with all educational partners, consensus was that in order to ensure a charter renewal in four years the following two goals will continue to be the focus for the next year:

Goal 1: Students who graduate from VOCS will be prepared to enter a higher education and/or pursue a career path.

Goal 2: All VOCS sites will strive to create and promote a safe, secure, and inclusive school environment that is accessible and conducive to student learning.

A review of the needs, conditions, and circumstances of our socioeconomically disadvantaged students and all students were considered when developing Goal 1, especially in the area of mathematics and ELA. After gathering input from all educational partners, Valley Oaks Charter School believes the actions within this goal will assist our socioeconomically disadvantaged students to be prepared to enter a higher education and/or pursue a career path. Other key features VOCS 2023-24 LCAP - Goal 1 include:

Providing supplemental instructional/intervention materials, curriculum, and software to personalize and improve student learning for socioeconomically disadvantaged students, Foster Youth, and English Learners;

Providing a reliable and secure digital network to continually enhance and improve VOCS instructional program, available resources, and staff productivity; and to enhance learning for socioeconomically disadvantaged students, Foster Youth, and English Learners;

Hiring a full-time counselor to provide academic counseling and support to students, especially SED students and Foster Youth students, so all students have a path for college, career and/or life after high school readiness, which may include A-G requirements, CTE courses, and/or life skills and assist with graduation rates;

Providing a career associate to assist students with their individual learning plans based on student's plan for life after high school, giving priority to students with unique needs; and identify students who are in danger of failing to provide referrals to the Student Support Team for targeted support;

Working with VOCS teaching staff, support staff will provide targeted support and tutoring sessions to students who are in danger of failing, giving priority to SED and EL students, especially to students not meeting the standards in CAASPP in the area of mathematics and ELA;

Providing supplemental EL curriculum, materials, and on-line resources, as needed, to improve language acquisition, along with offering professional learning opportunities to VOCS teaching staff and parent educators related to EL resources and strategies to support EL students;

Providing additional support materials, as needed, for foster youth students and connect students with peer mentoring programs within KCSOS, along with provide transitional living skills and;

Offering professional development/learning opportunities for VOCS staff and parent educators in all content areas, especially in the areas of early literacy and mathematics, to improve academic progress, specifically with SED students.

Also, in order to assist VOCS efforts in creating and promoting a safe, secure, and inclusive school environment, VOCS will continue to find ways to address individual student needs to promote school connectedness. After gathering input from all educational partners and reviewing of the needs, conditions, and circumstances of our socioeconomically disadvantaged students and all students, it was determined that Goal 2 will continue to be a priority. VOCS believes the actions within this goal will assist our socioeconomically disadvantaged students to feel safe, secure, and connected to the school. Other key features VOCS 2023-24 LCAP - Goal 2 include:

Providing a part-time counselor to continue counseling at VOCS sites to support student's social-emotional needs by conducting risk-assessments, providing case management, and offering individual and group support, giving priority to unduplicated pupils;

Offering student incentives and making school improvements to help SED students and all students feel valued and welcomed at VOCS, bringing a sense of school pride and connectedness through school activities and enhancements;

Continuing to provide access to the VOCS Vendor Service Program to SED students to support community partnerships between VOCS students and local businesses throughout Kern County. However, after analyzing our data and working with our educational partners, it was determined that the money will now be used to pay for support staff that will work directly with the VOCS Staff, parents, and students. We will continue to provide the vendor service program, but will fund it with a different budget.

Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Engaging educational partners is a priority for Valley Oaks Charter School, making our school so successful. VOCS continues to consider all input shared by educational partners regarding our goals and identified needs and recognizes that not all expressed needs can be addressed in the LCAP due to limited LCFF resources. Due to our school's nature, communication with educational partners is done regularly with VOCS staff and administration. In the development process of the 2023-24 LCAP, Valley Oaks Charter School received input on a variety of programs and services. Throughout the school year, all educational partners had the opportunity to review progress, provide input, and support the implementation of actions through meaningful feedback. The VOCS principals met monthly to gather information using surveys that were sent out three times during the 2022-2023 school year, monthly school site, and virtual meetings with parent educators, students, staff, and the VOCS Governing Board. The VOCS Governing Board met on May 15, 2023, and May 22, 2023, to collect additional feedback and to approve the 2023-2024 LCAP.

A summary of the feedback provided by specific educational partners.

VOCS TK-12 Parents: Parent participation continues to be a high priority for VOCS, who facilitated opportunities for parent educators to share their thoughts, ideas, and needs. All parents, including parents of unduplicated pupils and students with exceptional needs, were able to offer input in making decisions for each site by completing surveys, attending in-person table meetings, attending in-person scheduled appointments, attending Town Hall meetings, responding to Parent Square announcements, sending emails, and/or making phone calls. Parent Educators also had opportunities to share input at routine individual table meetings, Valley Oaks Parent-Teacher Advisory Committee (VOPTAC) meetings held monthly, Governing Board meetings held six times throughout the school year, at the spring Town Hall meeting, and through emails and phone calls. Since VOCS has 23 EL students (2% of the student population), an ELPAC Committee is not needed.

Parent Educator's suggestions from the 2023-24 LCAP Educational Partners Survey, pertaining to LCAP Goal 1 include: Keep the Jr. High Academy offering math and writing classes, increase the amount of in-class instruction opportunities, continue parent workshops, maintain parent choice and special order curriculum, offer more life skills classes to help prepare students for life after high school, offer more electives and enrichment classes including a full-time music program, more field trip opportunities, and increase tutoring and counseling opportunities for students. Parent Educator's suggestions from the 2023-24 LCAP Educational Partners Survey, pertaining to LCAP Goal 2, include: Offer more activities and clubs for older students, provide mental disability training to staff, and increase the vendor service program.

VOCS Students: Communication with all students is essential to all VOCS staff. Students could offer input in making decisions for each site by attending monthly table and/or scheduled meetings, completing surveys, and/or receiving weekly emails, website notifications, Parent Square announcements, and/or Remind texts. ASB, Jr. ASB and Interact meetings were open to all students and allowed students to share their input and/or needs with VOCS staff and administration. Student suggestions from the 2023-24 LCAP Educational Partners Survey include more flexibility to demonstrate content knowledge, better communication between school and home, better food and more freedom on campus, more social opportunities and clubs on campus, more availability to tutoring, more elective options, lower the pressure and expectations of students, and classes/info to help with student feelings and emotions.

VOCS Certificated Staff: Certificated staff communicated with administration through weekly staff meetings, individual meetings, school-wide meetings, emails, and/or completing surveys. VOCS certificated staff also had opportunities to share input at the monthly VOPTAC meetings, the Governing Board meetings held six times throughout the school year and the spring Town Hall meeting. Suggestions for next year include: continue providing counselors/tutors to help with struggling students, continue creating individual learning plans based on student's abilities, needs, and plan for life after high school, improve the Tiered Support System, address chronic tardiness to class, continue and increase parent workshops and induction programs for families.

VOCS Classified Staff: Classified staff communicated with administration through weekly staff meetings, individual meetings, school-wide meetings, emails, and/or completing surveys. VOCS classified staff also had opportunities to share input at monthly VOPTAC meetings, Governing Board meetings held six times throughout the school year, and the spring Town Hall meeting. Suggestions for next year include providing more opportunities for students to pursue job training after high school--bringing in speakers, more opportunities on-campus for students outside of enrichment classes, and more space.

VOCS Principals/Administrators: Principals/Administrators met weekly to discuss the school's needs and share any concerns delivered by VOCS staff, students, and/or parent educators. Additionally, principals/administrators had opportunities to share input at monthly VOPTAC meetings and Governing Board meetings held six times throughout the school year and the spring Town Hall meeting. Suggestions for next year include: Provide professional development opportunities for targeted interventions for ELA, mathematics, and EL/foster support; provide learning opportunities to support homeschooling educators, keep counselors, tutors, and the career associate to provide support to students; maintain the mission of parent choice, including parent-selected materials, continue to provide special order curriculum and technology support and continue offering the vendor service program and student incentives.

SELPA Administration: Valley Oaks Charter School includes all students when collecting data and in the development of the LCAP. Therefore, students with disabilities are not called out individually. SELPA Administration met with VOCS on May 4, 2023, to discuss the successes and concerns found during the special education plan process. SELPA Administration provided feedback regarding the need for math and reading support for SWD students at VOCS and professional development training for the support staff who work with students with unique learning. They also noted the importance of assisting parent educators in finding alternative educational settings when students are not progressing academically.

Community/Partner Agencies: VOCS continued to reach out to KCSOS for EL, SELPA, Foster Youth/Students experiencing homelessness services, and curriculum and instruction services, as needed. Partnerships with Bakersfield College and Cerro Coso College were maintained, along with a partnership with KHSD/Regional Occupational Center (ROC) and Kern High School District for our high school students. VOCS partnered with Cal State University Bakersfield America Learns to provide tutors for students who needed additional support. With the help of our part-time counselor, the number of dual enrollment classes offered will increase next year to further work towards goal one. Lastly, local businesses throughout Kern County and the Buena Vista Museum want to continue their partnerships with VOCS to continue providing their services to students.

Bargaining Units: VOCS met with the bargaining units on May 2, 2023 and shared the current LCAP. Input was gathered from these educational partners and added to the new plan. Suggestions included having more staff trained in Trauma Informed Care to better understand and help SED students.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

After sharing data and collaborating with all educational partners, VOCS found several themes which influenced the development of the 2023-24 LCAP. VOCS also recognizes the hard work that has gone into providing the instructional/supplemental materials, intervention strategies, and guidance needed to reinforce the importance of academic growth for all our students. Valley Oaks is a unique school where most of the teaching is done in the home by our parent educators, so providing support and opportunities for parent educators to assist them with this task is the highest priority to VOCS. Aspects of the 2023-24 LCAP that were influenced by the educational partner's input include:

Parent Educators identified a need to continue the special order curriculum program to support individual student needs (Goal 1: Action 1.1), along with continuing parent workshops (Goal 1: Action 1.8). Additionally, parent educators identified a need to provide options for students wanting to enter directly into the workforce after high school and options for students who want to enter college after high school (Goal 1: Action 1.3 and 1.4). Continuing counseling opportunities for students were also considered a necessity for parent educators (Goal 2: Action 2.1). Parent educators would also like to continue on-campus activities to help with school pride and connectedness (Goal 2: Action 2.2). Lastly, parent educators would like to see the vendor service program price increase next year (Goal 2: Action 2.3).

VOCS students identified a need for better communication between school and home to improve school connectedness and enhance school activities held on-site (Goal 2: 2.2). Additionally, students identified a need for more social opportunities and non-academic clubs based on student needs and want. (Goal 2: Action 2.2) Also, more availability to tutoring and help with student feelings and emotions. (Goal 1: Action 1.5 and Goal 2: Action 2.1)

VOCS certificated, and classified staff identified the need to continue providing counselors and tutors to help struggling students academically, especially in mathematics and early literacy, and socially and emotionally. (Goal 1: Action 1.3, 1.5 and Goal 2: Action 2.1). VOCS staff would also like to see the career associate continue next year to assist with the student's individual learning plans based on the student's plans for life after high school (Goal 1: Action 1.4). Additionally, VOCS staff would like to see the counselor focus on the Tiered Support System to improve academics and reduce chronic tardiness to class (Goal 2: Action 2.1) VOCS staff also identified a need to boost school spirit to engage more students on-site (Goal 2: Action 2.2) and continue parent workshops and induction programs for families (Goal 1: Action 1.8).

VOCS Principals/Administrators identified a need for professional development opportunities/parent educator workshops to include targeted interventions for ELA (specifically early literacy), mathematics, and EL/foster support (Goal 1: Action 1.6, 1.7, and 1.8). Principals/Administrators also see the necessity to continue providing counselors and tutors to help with struggling students both academically, especially in mathematics and early literacy, and socially and emotionally. (Goal 1: Action 1.3, 1.5 and Goal 2: Action 2.1). Additionally, being able to maintain the VOCS mission of parent choice, including parent-selected materials and technology support, was

identified by principals and administrators (Goal 1: Action 1.1 and 1.2). Lastly, the administration identified community partnerships and student incentives as necessary at VOCS (Goal 2: Action 2.2 and 2.3) to help with school connectedness and spirit.

An explanation of why the LEA has developed this goal.

2022 CAASPP data shows that All Students (3rd-8th and 11th graders), school-wide, averaged the following results: English Language Arts (ELA) - 41% of VOCS students meet or exceeded standards, while 27% of VOCS students nearly met the grade-level standards. Mathematics - 26% of VOCS students meet or exceed standards, while 28% of VOCS students nearly met the standard. The overall performance level for ELA and Mathematics was rated low. The overall performance levels for Graduation Rate (84.8%) and Chronic Absenteeism (7%) were rated medium. There was no 2022 report for College/Career. These indicators are found in four LCFF Priorities: Priority 1: Conditions for Learning; Priority 4: Pupil Outcomes/Pupil Achievement; Priority 7: Course Access; and Priority 8: Student Outcomes

Also, 2022 CAASPP data shows performance gaps between All Students and students with disabilities (SWD) where 73% of SWD students did not meeting the standards, while only 46% of All Students did not meet the standards in the area of mathematics. Additionally, socioeconomically disadvantaged (SED) students performed in the low level, while SWD performed in the very low performance level. The CA School Dashboard indicates that 84.8% All Students graduated, with 81% of SED students graduating. Also, 27% of All Students met A-G completion with 12% of SED students meeting the A-G completion. Finally, the percentage of pupils who participated in and demonstrated college preparedness on EAP were ELA: 24.59% and Math: 10%, with SED students scoring 17.39% in ELA and 4.35% in Math. All of these indicators are found in four LCFF Priorities: Priority 1: Conditions for Learning; Priority 4: Pupil Outcomes/Pupil Achievement; Priority 7: Course Access; and Priority 8: Student Outcomes

VOCS student achievement data demonstrate a need to increase the academic performance of all students in meeting or exceeding grade-level standards, especially in mathematics and ELA. Input from educational partners also identified a need to implement an individualized instructional program for each student while supporting parent educators to meet the needs of all students. Specifically, feedback was given on the additional needs in supporting SED and SWD students struggling in mathematics and early literacy. VOCS will accelerate student learning by maintaining the percentage of fully-credentialed staff and strengthening grade-level standards-based instruction and targeted intervention, especially in early literacy and mathematics. Purposeful enrichment opportunities, supported by data analysis and a commitment to ongoing cycles of inquiry, will ensure all students attain increasingly higher levels of achievement. By doing this, students who graduate from VOCS will be more prepared to enter a higher education and/or pursue a career path.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Goal one is designed to provide teaching and learning opportunities to meet the needs of each student through the collaborative work of VOCS staff and parent educators. Many of our goal-one actions were implemented as planned; however, two were not feasible during the 2022-2023 school year. Action 1.3 full-time counselor was partially implemented as planned because the counselor left mid-year to work for a different district. Five support staff and administration met the caseload of 176 students (36% SED, 3% EL) that the counselor intended to help support. They reported that 98% of students maintained on level 2 tier system and passed their classes. The five foster youth students at VOCS did not require supplemental services (Action 1.7). These two actions did not affect the overall progress toward goal one. VOCS will continue to review unduplicated students' needs, conditions, and circumstances.

An explanation of how effective the specific actions were in making progress toward the goal.

Action 1 (TK - 12 Supplemental Curriculum/Materials) and Action 8 (Professional Learning) 2023 Local Survey reports that 46.2% of all families participate in the VOCS Supplemental Curriculum Program, an increase of 5% from 2022 results, and 45.4% of VOCS parents attended one or more parent workshops, down 6.4%. VOCS considers this progress towards our goal, as we returned to in-person-only options after the pandemic, which we believe is the reason for the slight decline in attendance. However, local data from the last full school year prior to the pandemic, 2019, reports that 32% of VOCS parents attended one or more parent workshops. This is a 13.4% parent participation increase for our first entire school year back from the pandemic.

Action 2 (Technology Support): 2023 Local Survey reports that 98.8% of VOCS educational partners say that VOCS provides students with all the textbooks and learning material, including allowing students to check out a Chromebook to use home, which 41% of all students have done.

Action 3 (Full-Time Counselor), Action 4 (Career Associate), and Action 9 (Program Specialist) 2023 Local Survey reports that 97.3% of all families believe that VOCS provides students with a strong foundation for their future college and/or careers, an increase of 7.3% from 2022 results. 2021-2022 graduation rate for unduplicated students pulled from KernKids in March 2023 is 76.5%, a 1.5% increase from 2020-2021 data.

Action 5 (Support Staff): 2022-23 STAR Renaissance results re ported on the Kern KiDS in April 2023. The data shows that in Fall 2022, 59% of Overall Students, 53% of SED students, and 40% of EL students were becoming more proficient in reading. Additionally, 59% of Overall Students, 49% of SED students, and 50% of EL students have shown improvement in their math proficiency levels. Furthermore, when we compare our 2022 CAASPP scores to the 2019 data, we see an overall student increase of 5% for ELA and 4% for Math. Specifically, 46% of all students and 43% of SED students exceeded or met the standard for ELA, while 26% of all students and 17% of SED students exceeded or met the standards for Math.

Action 6 (English Learner Support): According to the 2022 CA School Dashboard, 61.5% of VOCS students were making progress towards English language proficiency (13 students). 23% decreased at least one ELPI level, 15% maintained ELPI levels 1, 2L, 2H, 3L, and 3H, 0% maintained ELPI level 4, and 61.5% EL students progressed at least one ELPI level.

Based on the analysis of these results, VOCS believes actions are showing to be effective in making progress towards the goals.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

After consulting with educational partners, the most significant change to this goal will be with the actions. It was determined that Action 1.5 would change from Tutors to Support Staff to include the paraprofessionals that were hired using ELO funding during COVID. The funding has been exhausted, but it is still a need identified by educational partners, so paraprofessionals will be moved into the LCAP plan to continue supporting our students, especially our SED and EL students. A change to the metric for priority 8(a) Pupil Outcomes was added to include 2023 STAR results. In addition to this, salaries and benefits and the cost of goods have increased, which are reflected in our metrics.

Promoting a safe, secure, and inclusive school environment is a top priority for all educational partners. Providing an environment where students feel safe and welcomed increases student engagement, academic and social/emotional growth, graduation, and transition. According to the 2022-23 Annual Survey, 88% of VOCS 4th-12th grade students feel connected to VOCS while on campus, and 92% of students feel engaged while on site. Additionally, the 2022-23 Annual Survey reports 94% of educational partners feel VOCS demonstrates caring and concern and has high expectations for students in an environment that honors individual differences and is conducive to learning. Continuing to create and promote a safe, secure, and inclusive school environment that is accessible and conducive to student learning is an integral part of the vision and mission of VOCS. Goals and actions will help achieve this goal, especially for our socioeconomically disadvantaged students.

Actions and services within this goal will help VOCS expand collaborative partnerships with students, parents, staff, and the community. These partnerships will enable wrap-around services and personnel to further open lines of communication between students and VOCS, fostering a safe and welcoming educational environment. Additionally, school improvements and student incentives will provide opportunities for students to feel engaged and connected to VOCS. All educational partners will then be actively engaged while creating and promoting a safe, secure, and inclusive school environment that is accessible and conducive to student learning. Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Goal Two was designed to provide opportunities to meet the needs of each student through the collaborative work of VOCS staff and parent educators. Actions were implemented as planned; however, to ensure VOCS was meeting the social-emotional needs of our students returning to in-person school after the pandemic, the part-time counselor (Goal 2: Action 1) increased from .4 FTE to .6 FTE. To meet these needs, the caseload of our part-time counselor increased from 158 students to 251 students. All student's needs were met, with priority going to unduplicated groups. Additionally, there was an increase in students returning to in-person community partnerships due to people resuming pre-pandemic activities. This increased activity did not affect the implementation of (Goal 2: Action 3) but did cause a material difference in budgeted expenditures.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 1 (Part-Time Counselor): Actual cost for contract exceeded budgeted amount.

Action 2 (School Pride and Connectedness): No material difference.

Action 3 (Community Partnerships): Additional funds were needed due to increased participation with in-person activities resuming, and people opting to do more as we continue to come out of the pandemic.

An explanation of how effective the specific actions were in making progress toward the goal.

Action 1 (Part-Time Counselor): According to the 2023 annual survey of 4th-12th grade students, 92% reported being engaged while at VOCS, 91% feel that VOCS is preparing them for future college and/or career paths, and 94% feel VOCS demonstrates caring, concern and has high expectations for students in an environment that honors individual differences and is conducive to learning.

Action 2 (School Pride and Connectedness): According to the 2023 annual survey of educational partners, 92% reported feeling connected to VOCS, 88% reported feeling valued as an important partner of VOCS, and 90% thought that they had opportunities to be a part of the decision at VOCS.

Action 3 (Community Partnerships): According to the 2023 annual survey 52.67% of all students participated in a vendor service.

Based on an analysis of these results, VOCS believes the actions in Goal 2 are showing to be effective in making progress towards the goal.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

After consulting with educational partners, changes were made to actions within Goal Two. One-time grant money used to pay for instructional aides and paraprofessionals ended, so the contributing dollars for Community Partnerships were moved to Action 1.5 Support Staff to continue providing tutoring, instructional aides, and paraprofessionals for our VOCS students and staff. The Educational Partners of VOCS have expressed their desire to keep community partnerships as part of VOCS, so funds were adjusted to maintain the partnerships. However, the funding for Community Partnerships will be non-contributing dollars. In addition, salaries and benefits and the cost of goods have increased, which are reflected in our metrics.

Required Descriptions

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

VOCS acknowledges the need to continue spending our time and resources to improve student performance. CAASPP testing resumed in the 2021-2022 school year. Since VOCS is a parent-choice, parent-participation, independent/homeschool charter school, the school recognizes that consistency throughout the grade levels can vary from family to family and year to year. Valley Oaks Charter had no student groups that were two or more performance levels below all student performance on the CA Dashboard.

Actions and services are based on improving outcomes for student groups, specifically Socioeconomically Disadvantaged Students (SED) and English Learners (EL). 2022 CAASPP data shows that All Students (3rd-8th and 11th graders), school-wide, averaged the following results: English Language Arts (ELA) - 54% of all VOCS students did not meet standards, 63% of SED did not meet the standards, and 100% of EL students did not meet the standards. Mathematics - 74% of all VOCS students, 83% of SED, and 100% of EL did not meet the standards, resulting in low overall performance for ELA and Mathematics. Many SED and EL students enroll at VOCS because they seek an alternative to the traditional classroom environment that is not working for them, and they enter VOCS below grade level in reading and math. Due to this, VOCS works closely with parents and students to close the achievement gaps and bring all students up to grade level by offering parent workshops to educate them on how to teach their students, individualize the curriculum to each student, as well as provide additional tutoring and counseling supports to SED and EL students. Getting parents to bring their students to campus can be challenging. To help

combat that issue, VOCS uses a full-time counselor (Goal 1: Action 1.3) to lead the MTSS program and build a trusting and supportive relationship with students, parents, and staff to address academic concerns.

Based on the data presented, it is clear that there are significant gaps in student performance across several key areas that VOCS will continue to focus on. Specifically, English Language Arts and Mathematics are areas where students need help to meet standards, with the situation being particularly challenging for SED and EL. In addition, chronic absenteeism is a concern for all students but is much more pronounced among EL students. The overall performance levels for Graduation Rate (84.8%) and Chronic Absenteeism (Chronic Absenteeism Rate was 7% and reported all students performed in the medium status level, EL: 37.5% not enough students to have a status level, SED: 12.2% status level high). There was no 2022 report for College/Career. VOCS has been actively supporting their SED and EL students by addressing their challenges, such as cultural and language differences. The 2023 local Survey reports that 56.52% of EL pupils participate in our supplemental curriculum program (Goal 1: Action 1), and VOCS will continue to provide this service to address individual learning needs. The school will continue to hire support staff (Goal 1: Action 5) dedicated to assisting students with language acquisition and bridging the cultural gaps among them. To further bolster student support, VOCS will keep providing Chromebooks and hotspots (Goal 1: Action 1.2) to enable access to the online curriculum while off-campus. VOCS will monitor the effectiveness of these actions with state and local data (Chronic Absenteeism Rate, Graduation Rate, Academic Achievement, and local surveys). These indicators are found in four LCFF Priorities: Priority 1: Conditions for Learning; Priority 4: Pupil Outcomes/Pupil Achievement; Priority 7: Course Access; and Priority 8: Student Outcomes.

Additionally, the 2022 CA School Dashboard indicates that 84.8% of All Students graduated, with 81% of SED students graduating and 66.67% of EL students graduating. 27% of All Students met A-G completion, 12% of SED students met A-G completion, and 0% of EL students met A-G requirements. The percentage of pupils who participated in and demonstrated college preparedness on EAP was ELA: 24.59% and Math: 10%, with SED students scoring 17.39% in ELA and 4.35% in Math. Many SED and EL parents do understand the importance of A-G classes and opt to allow their students to take general education classes. To combat this, the VOCS counselors (Goal 1: Action 1.3 and Goal 2: Action 2.1) will continue working on teaching parents and students the importance of the A-G classes by offering enrollment workshops and holding yearly meetings to discuss the academic pathway their students are on. Additionally, counselors will offer parent workshops throughout the year to focus on college readiness, help students enroll in dual enrollment classes, as well as hold workshops at the end of the school year for parents of all incoming ninth-grade students to educate them on the importance of A-G classes. To ensure that students are on track for success, in addition to workshops, VOCS school counselors will utilize the Early Warning System in Kern KiDS to monitor student progress, including A - G completion. This system will identify students in danger of failing by tracking their attendance and grades throughout the year. Furthermore, both teachers and counselors will use the Early Warning System to implement a tiered system of support, providing students identified with the necessary resources to address and correct their grades and absences early on. VOCS will implement a study hall with tutoring options for identified students. The Career Associate and support staff (Goal 1: Action 1.4 and 1.5) will be available to assist with assignments and provide additional academic help outside of class during study hall. These actions will promote student success and ensure that all students at VOCS have the opportunity to thrive academically and personally. As needed, additional academic and counseling support will be provided to our EL and foster students (Goal 1: Action 1.6 and 1.7). All of these

indicators are found in four LCFF Priorities: Priority 1: Conditions for Learning; Priority 4: Pupil Outcomes/Pupil Achievement; Priority 7: Course Access; and Priority 8: Student Outcomes

We are committed to providing ongoing support and resources to our parent educators to help gain academic success. While our supplemental curriculum and materials program (Goal 1: Action 1.1) has seen participation from 46% of all parents and 25% of SED parents, we understand the challenge of monitoring progress when parents use a variety of curricula and teaching strategies. Therefore, with the help of the Program Specialist, VOCS is implementing grade-level standard benchmarks (Goal 1: Action 1.9) that will guide teachers and parent educators to track their student's progress throughout the year. To ensure regular assessment of student progress, we will administer a range of assessments, including benchmark, written, and oral tests, ESGI for early literacy, and STAR Renaissance testing (Goal 1: Action 2). We are also committed to providing professional development training to all staff to create and implement essential standards, common formative assessments, and professional learning communities (Goal 1: Action 1.8). These tools will help teachers and staff gather real-time data, monitor progress, and quickly give targeted interventions to all students. VOCS will continue to provide tailored professional development workshops to teachers and parents focused on Math and early literacy to support those working with SED, EL, and exceptional needs students. VOCS will track the effectiveness of its actions by analyzing both staff surveys on how professional development has enhanced their skills (Goal 1: Action 1.8) and state and local data for academic achievement aligned with the grade level benchmarks (Goal 1: Actions 1.2 and 1.9).

Creating and promoting a safe, secure, and inclusive learning environment that is accessible and conducive to student learning is a fundamental aspect of VOCS' vision and mission. Ensuring students feel safe and welcomed significantly enhances student engagement, academic and social/emotional growth, graduation rates, and successful transitions. According to the 2022-23 Annual Survey, 88% of VOCS students, ranging from fourth to twelfth grade, feel connected to VOCS, while an impressive 92% feel engaged while on campus. The report also shows that 94% of educational partners expressed satisfaction with VOCS' caring and supportive approach and high expectations for students, creating an environment that values and nurtures individual differences and promotes a conducive learning culture. Of the educational partners surveyed, 88% feel valued by VOCS, while 96% reported feeling safe on campus, with a notable 100% of EL educational partners feeling secure on VOCS campuses.

Our commitment to creating a welcoming, inclusive, and safe environment for all students at VOCS remains unwavering. Our excellent track record of discipline is a testament to our importance in promoting emotional well-being and fostering an inclusive and supportive learning environment that recognizes each student's unique needs and differences. We take pride in achieving a 100% connectedness rating from our EL and Foster Youth educational partners. We are committed to providing a positive, inclusive learning environment that promotes student well-being and academic achievement. While our students aren't on campus for five days a week, we remain committed to creating opportunities for engagement and promoting school pride (Goal 2: Action 2.2). However, we also recognize the issue of chronic absenteeism, with 7% of all students being chronically absent, especially for our EL Chronic Absenteeism Rate of 37.5% and SED Chronic Absenteeism Rate of 12.2%. To address this issue, we will continue improving school connectedness by providing counseling services, community partnerships, and school incentives for attendance and completed work assignments. Research-backed best practices for

student engagement will guide our efforts. We are committed to ensuring that all students, especially those with SED and EL needs, feel valued and engaged within VOCS and the wider community. These actions, outlined in Goal 2: Actions 1-2, will positively impact our student's well-being and academic progress in the long run. VOCS will monitor the effectiveness of these actions by looking at our student and parent connectedness surveys and tracking progress of our Chronic Absenteeism Rates for our EL and SED students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

VOCS will continue actions and services to support our socioeconomically disadvantaged (SED) students, English Learners (EL), and foster youth. In addition to the actions and services being provided LEA-Wide or Schoolwide, the actions that are increased or improved include the EL supplemental materials/resources, foster youth support, professional learning opportunities for SED, EL and foster youth parent educators, and staffing to support student needs. Professional development learning opportunities in CCSS and ELD will continue to be offered to VOCS staff and parent educators. Additionally, VOCS will continue creating and improving grade-level standard benchmarks so that parent educators will have the tools to ensure their student(s) is making academic progress through the school year. These additional actions meet and/or exceed the totality of the required percentage increase compared to all student services.

The support staff will continue to be hired to assist students needing targeted instruction in ELA and mathematics, prioritizing SED and EL students. Additionally, benchmark assessments, written and oral assessments, and STAR Renaissance testing will be used throughout the school year to assess the academic progress of our students. Educational strategies and online support and resources will also be further investigated by VOCS staff to assist parent educators in implementing strategies at home with their students, focusing on the areas of ELA, including early literacy and mathematics. Parent educator workshops will continue to be developed and offered to help parent educators in ELA, mathematics, and EL strategies, especially for our students that struggle the most, which may include SED and EL students.

Additional actions to support English Learner Resources and Professional Learning are:

Goal 1 Action 6 (English Learner Support) provides supplemental curriculum and materials for EL students to assist with improving language acquisition. These actions will provide professional learning opportunities for VOCS teaching staff and parent educators related to EL resources and strategies.

2022 CA School Dashboard: 2% of VOCS Students were English Learners, and 61.5% of English Learners were making progress toward English language proficiency

Considering the EL progress and reclassification rates, VOCS must provide additional professional learning to support EL students. Professional development will continue to have VOCS teachers review ELD standards, understand EL proficiency levels, determine the difference between designated and integrated ELD, and check writing language objectives and academic conversations. VOCS teachers

could use this information to support their English learners and parent educators. Further, students will be supported by data analysis and a commitment to ongoing cycles of inquiry, ensuring all students attain increasingly higher levels of achievement. The action will also incorporate a school-wide data system to measure student progress on local assessments and provide supplemental classroom materials to support the core program when EL students struggle with academic standards. This action is intended to provide continued support for our EL students.

An additional action that supports Foster Youth are:

Serving Foster Youth is important to VOCS. Goal 1 Action 7 provides additional support materials for Foster Youth and connects students with peer mentoring programs through KCSOS. This action will continue to offer support Foster Youth students and provides supplemental materials for VOCS staff and parent educators to assist our Foster Youth students.

To improve the skills of all students and prepare them for success in higher education and future careers, VOCS will provide personalized instruction that considers the unique academic and socio-emotional needs of EL, SED, and Foster Youth students. This includes a strategic integration of personalized learning experiences tailored to each student's specific learning needs. Using data, the levels of all student performances will raise/improve, including EL reclassification, to a high level of proficiency in CCSS and 21st-century learning through specifically designed interventions, enrichment, differentiated classroom instruction, project-based and blended learning, and parent education for all students, including VAPA (Visual and Performing Arts) and foreign language.

(Measurable Outcomes [Effective In])

 the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

LCFF Carryover Table

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
