

Budget Overview for the 2024-25 School Year





Of that amount, \$98,491 is tied to actions/services in the LCAP and \$582,111 is not included in the LCAP. 

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Linns Valley-Poso Flat Union School District is projecting it will receive \$40,791 based on the enrollment of foster youth, English learner, and low-income students. Linns Valley-Poso Flat Union School District must describe how it intends to increase or improve services for high needs students in the LCAP. Linns Valley-Poso Flat Union School District plans to spend \$56,791 towards meeting this requirement, as described in the LCAP.

Through a review and analysis of our implementation with the actions in Goal 1, we have found the following insights between our planned actions and actual implementation.

The implementation of following actions were deemed successful as they were each fully implemented as planned:

- Action 1.1 Extra Curricular Activities was fully implemented. No less than 7 events throughout the school year were planned, held, and well attended. 100% of students participated in small school activities, athletic competitions, and social events.
- Action 1.2 Well-Rounded Education was fully implemented. During the 2023-24 school year, art supplies were purchased and art lessons were provided to all students (TK-8th within the classroom). 100% of students participated in these well-rounded educational activities. LVSD intended to provide a well-rounded education to improve grade-level mastery of standards for students who may be behind in academic achievement and was able to provide these educational activities.
- Action 1.3 Supplementary Materials was fully implemented. During the 2023-24 school year, intervention and supplemental materials were purchased, including online educational program subscription. Materials were well utilized by staff and received bystudents. 100% of students participated in small group instruction to target learning loss. LVSD intended to provide supplemental materials to improve grade-level mastery of standards for students who may be behind in academic achievement; this was accomplished.
- Action 1.4 Academic Support was fully implemented. During the 2023-24 school year, LVSD maintained one paraprofessional who assisted in response-to-intervention activities and other academic instructional support. 100% of students participated in classes with a paraprofessional to support academic achievement. LVSD intended to provide support services and academic intervention for low-income students, by using a paraprofessional to support academic achievement in grade-level standards for ELA and Math; this was accomplished.

Action 1.5 - High Quality Teacher was fully implemented. During the 2023-24 school year, additional high quality (HQ) teacher helped provide smaller class sizes and targeted, grade-specific lessons. 100% of students participated in a class and educational lessons taught by an HQ teacher. LVSD intended to provide and maintain a highly qualified teacher, to provide opportunities for students to learn to read through small class sizes and similar abilities; this was implemented as planned.

Action 1.6 - Positive Playground Activities was fully implemented. During the 2023-24 school year, playground facilities and equipment were purchased and installed. All students participated in the increased services and activities during recess periods. LVSD intended to provide additional activities for students during recess periods; this was implemented as planned.

Action 1.7 - Professional Development was fully implemented. LVSD intended to have multiple AVID coaching sessions throughout the year to all instructional staff. These professional development activities were implemented as planned.

No substantive challenges in the implementation of actions described in Goal 1 were experienced during the 2023-24 school year.

Linns Valley conducted an analysis of material difference between Budgeted Expenditures and Estimated Actual Expenditures. The total budgeted for the 2023-24 LCAP Goal 1 was \$97,621. The estimated actual expenditures for 2023-24 LCAP Goal 1 was \$94,469. This is a difference of \$3,152.

Most actions had no material difference in budgeted expenditures versus estimated actual expenditures. The actual expenditures for Action 1.2 (Well-Rounded Education) and Action 1.3 (Supplementary Materials) were less than anticipated due to existing materials. Also, there was a slight difference in Action 1.4 as actual expenditures were slightly higher due to increased personnel costs.

The effectiveness of the planned actions in Goal 1, including the implementation of our actions designed to increase student attendance (Actions 1.1 and 1.6) and actions implemented to increase grade-level academic success (Actions 1.2, 1.3, 1.4, 1.5, and 1.7), has been instrumental in setting a foundation for accelerating student learning and promoting a safe and positive environment during the three-year LCAP cycle.

Actions 1.1 and 1.6 focused on increasing student attendance and were deemed effective. LVSD did reach the 3-year desired outcome for student attendance rate (90%). Additionally, our school facilities and the playground continue to receive a rating of "GOOD" on the FIT report at 100%.

Actions 1.2, 1.3, 1.4, 1.5, and 1.7 focused on increasing grade-level academic success. Due to the low number of students in attendance, LVSD does not receive dashboard data from the CAASPP administration. Thus, local assessments and benchmarks are utilized to measure the effectiveness of academic success. Based on these measures, the desired outcomes for ELA and Math over the three-year LCAP cycle were met. On the ELA/reading assessments, the desired outcome was for 53% of low-income students and 68% of all students to meet or nearly meet grade-level standards. Local assessments show that 82% of low-income students and 75% of all students meet or nearly meet grade-level standards. On the Math assessments show that 73% of low-income students and 56% of all students meet or nearly meet grade-level standards. Local assessments show that 73% of low-income students and 75% of all students meet or nearly meet grade-level standards. These specific actions are deemed effective in making progress toward the goal during the three-year cycle.

The implementation of the following actions were deemed successful as they were each fully implemented as planned:

Action 2.1 - Stakeholder input was fully implemented. During the 2023-24 school year, engaged educational partners no less than three times with the intent to provide meetings, surveys, and questionnaires to obtain educational partner feedback to ensure the voice of our unduplicated parents. This action was implemented as planned.

Action 2.2 - Bobcat Newsletter was fully implemented. LVSD intended and provided school informational notices through the Bobcat Newsletter to parents and families to expand and provide open communication with educational partners and foster a safe and welcoming educational environment. This action was implemented as planned.

Action 2.3 - Stakeholder Activities were fully implemented. LVSD held all educational partner activities and social events planned throughout the year. There was a graduation ceremony for Kindergarten but no graduation ceremony for 8th grade as there were no 8th grade students. This action was implemented as planned.

Action 2.4 - Web-based Program: ParentSquare was fully implemented. LVSD purchased and utilized a web-based program to increase communication with parents, teachers, and administrators. This action was implemented as planned.

No substantive challenges in the implementation of actions described in Goal 2 were experienced during the 2023-24 school year.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Linns Valley conducted an analysis of material difference between Budgeted Expenditures and Estimated Actual Expenditures. The total budgeted for the 2023-24 LCAP Goal 2 was \$1,950. The estimated actual expenditures for 2023-24 LCAP Goal 2 was \$1,777. The actual estimated expenses were \$173 less than budgeted.

There was minor differences in budgeted expenditures versus estimated actual expenditures, specifically in Action 2.1 (Stakeholder Input). The difference in Action 2.1 was for the survey service, Kwik Survey (Shout) which this difference was due to final pricing for this service.

Adjustments to the budgeting for actions will be considered for the 2024-25 LCAP.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The effectiveness of the planned actions in Goal 2, including the implementation of our actions designed for stakeholder input (Action 2.1), stakeholder activities (Action 2.3), and communication systems (Actions 2.2 and 2.4), has been instrumental in setting a foundation for a safe and welcoming environment by expanding collaborative relationships with open communication and educational partner participation during the three-year LCAP cycle.

Actions 2.1, 2.2, 2.3, and 2.4 (expand collaborative relationships, open communication, and increased educational partner participation) were somewhat effective. An analysis of effectiveness for these actions over the three-year LCAP cycle was determined through metrics included within LCFF Priority 3 (parent participation) and Priority 6 (school climate). Based on our current progress with suspension rates and parent participation, LVSD did not make our intended three-year desired outcomes. However, LVSD did meet our desired outcome for Expulsion rates by maintaining a 0% over the three-year period.

Priority 3: Educational partner survey participation decreased from 50% to 30% for all students (50% for families of unduplicated students). These results fell short of LVSD's desired outcome of 75% of all surveys received. Despite this shortfall in responses, LVSD had 90% of all parents and 50% (one of two) of unduplicated families attend in-person meetings for parent input. Additionally, 100% of all parents including those of unduplicated pupils and students with disabilities receive two-way communications for all school events, transportation updates, grades, behavior, and other school updates. Based on this information and feedback from educational partners, LVSD believes these actions have been (and continue to be) effective and necessary for making progress towards the goal.

Priority 6: In terms of school connectedness, 95% of students agree or strongly agree with feeling safe and connected at school. This nearly meets the desired outcome to have 100% agreement for this metric. In terms of expulsion rates, LVSD has met it's desired outcome of maintaining a 0% expulsion rate over the three-year period. In terms of suspension rates, LVSD has maintained a 0% suspension rate for 2 of the 3 years for the current LCAP cycle. Despite, there were 4 student suspensions during the 2023-24 school year. The desired outcome for the three-year LCAP cycle was not met on this metric.

Educational partner feedback reported that by providing the Bobcat newsletter and ParentSquare, there was increased communication between students, parents, staff, and the community. By providing the educational partner activities, we hoped for an increase in attendance and an increase in meeting, survey, and questionnaire participation. There was an expansion in collaborative partnerships with students, parents, staff, and the community fostering an overall safe and welcoming educational environment.

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Linns Valley School spans a vast area of 350 square miles in northeast Kern County and is nestled in the rural community of Glennville, California, roughly 45 minutes northeast of Bakersfield. Serving Transitional Kindergarten through Eighth Grade, our district is enriched by federal funding from Title I, Title II, and Title IV, although our Title I resources have significantly decreased recently. Currently, our school has an enrollment of 19 students with an average daily attendance of 17.4.

At Linns Valley, we pride ourselves on fostering cultural awareness every day through our diverse selection of literature. We are dedicated to building a cohesive school community where parents, students, and staff collaborate to ensure a secure and vibrant learning atmosphere for all students. Our efforts focus on upholding high academic standards, reinforcing the value of self-worth, maintaining a safe and orderly environment, and cultivating an atmosphere that motivates and supports students to excel and achieve their highest potential.

Support for our educational activities comes from supplemental and Concentration funding, primarily directed to the 68% of our students who come from low-income families. The Glennville community, home to about 195 residents, supports our educational initiatives. In our classrooms, technology integration is a key component, with students engaging in online educational platforms like MobyMax, Epic, Accelerated Reader, Studies Weekly-History, HRW for Language Arts and Math, and Generation Genius, which supplements our science curriculum aligned with the Next Generation Science Standards (NGSS).

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Linns Valley School, due to its size, does not receive student data representation on the California Dashboard. Our school does not report on the Dashboard because we have fewer than 30 students in each group. However, our internal assessments (e.g., MobyMax) show promising progress in academic achievements across various student groups.

This year, we've observed significant advancements in grade-level standards. For instance, 82% of our low-income students are now meeting or almost meeting the standards in Language Arts, and 75% of all students achievement rate of our entire student body. 75% of all students are meeting or almost meeting the standards in math and 73% of our low-income students are meeting or almost meeting the standards in math.

From the 2022-23 to the 2023-24 school year, all students went down slightly in Language Arts, with achievement scores from 80% to 75%. We did, however, see a year-over-year increase in Math scores as they rose for all students from 73% to 75%. Among our low-income students, there has been a notable increase in reading/ELA as they scored at 82% reaching near or at standard levels in 2024, up from 75% in 2023. For Math, our low-income students were down slightly at 73% reaching near or at standard levels in 2024, down from 75% in 2023.

We are proud of our success in maintaining a 0% suspension rate for three of the four years, a testament to the effective collaboration between parents and staff who foster positive student behavior. However, it was a challenge maintaining this same rate during the 2023-24 school year as four students (21%) were suspended.

Moving forward, we plan to enhance our educational strategies through targeted classroom discussions, ongoing feedback during lessons, and effective goal setting, utilizing effective instructional strategies (e.g., universal readiness skills, AVID, 95% Program etc.). Our focus this year will include boosting student engagement from Transitional Kindergarten through 8th grade.

Upon reviewing the educational needs and circumstances of our students, especially those from low-income backgrounds, we recognize that academic gaps exist. Specifically, our low-income students (73%) are below all students (75%) in meeting or nearly meeting standards in Mathematics. Likewise in Math, our low-income students were down slightly at 73% this year from 75% last year. Closing these gaps remains a priority, as we continue to utilize local assessment tools like MobyMax for detailed academic tracking and support.

 - o This amount is the total of the Estimated Actual Percentage of Improved Services column.

 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).
