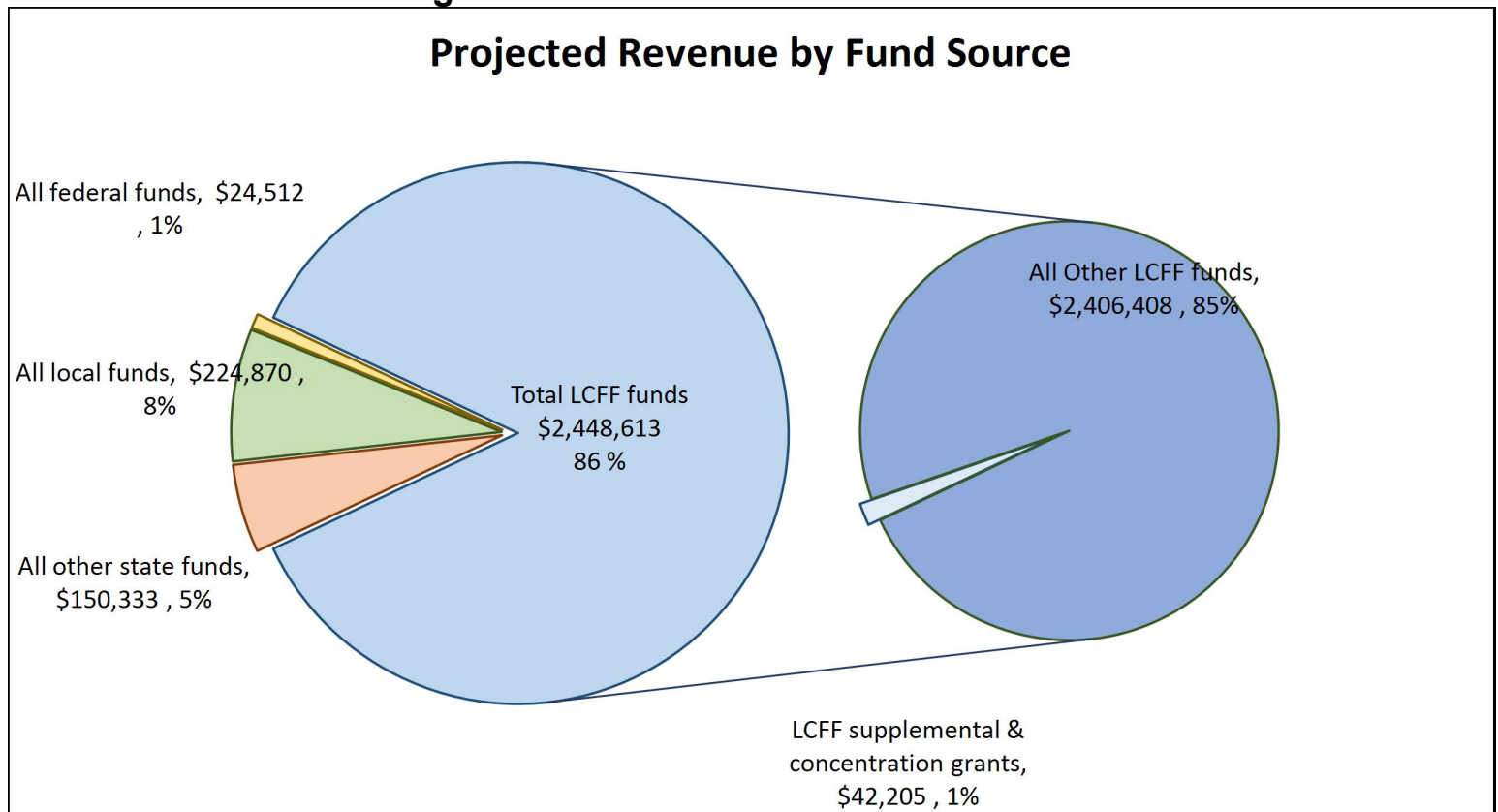

Budget Overview for the 2025-26 School Year

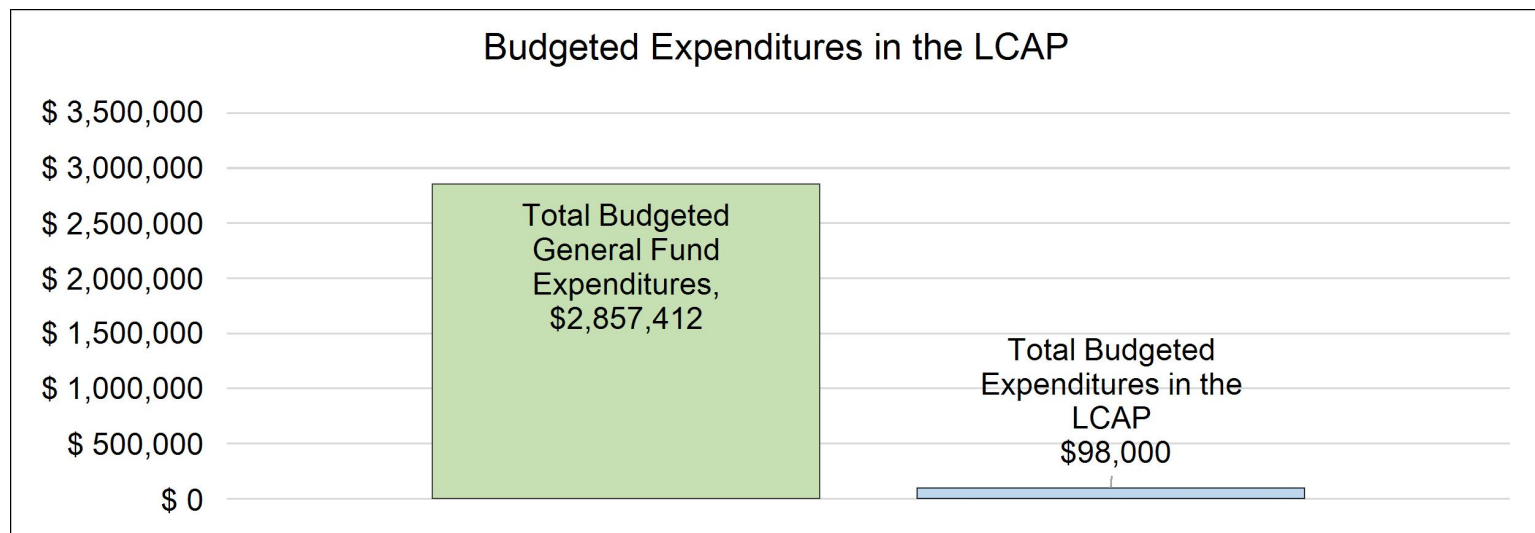


This chart shows the total general purpose revenue McKittrick Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for McKittrick Elementary School District is \$2,848,328, of which \$2448613 is Local Control Funding Formula (LCFF), \$150333 is other state funds, \$224870 is local funds, and \$24512 is federal funds. Of the \$2448613 in LCFF Funds, \$42205 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

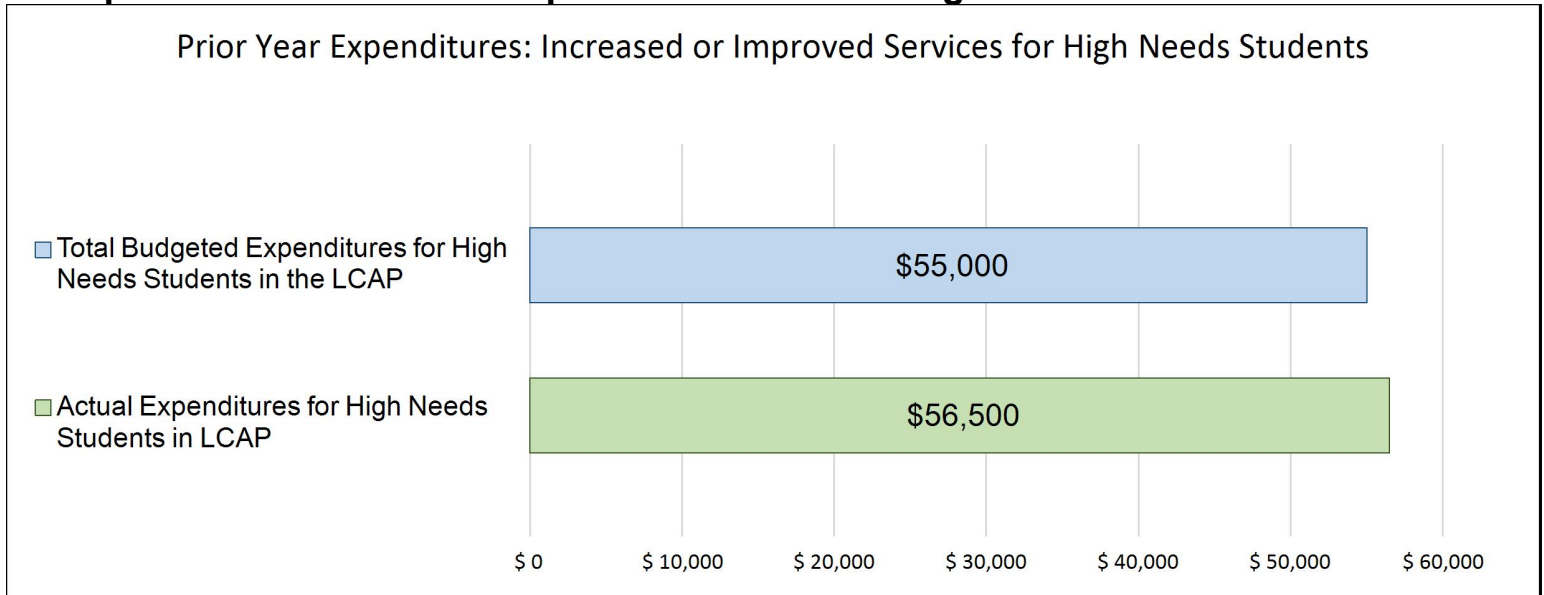

In 2025-26, McKittrick Elementary School District is projecting it will receive \$42205 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2025-26]

General Information

McKittrick Elementary School District is in a rural area on the far western side of Kern County. The school district's buildings are located 40 miles west of downtown Bakersfield at the intersection of highways 33 and 58. McKittrick is a single-site district serving 70 students in TK through 8th grade. McKittrick Elementary School's graduates attend Taft Union School District. Taft High is located 18 miles to the southeast. Traditionally McKittrick Elementary School students do very well academically and athletically. We serve a diverse student population consisting of:

Ethnicity: 58.% White, 33% Hispanic, 4% African American, and 1% Asian
Language: 97.0% English-only, 3.0% English learners
Economic Status: 57.0% of McKittrick's students have been classified as low-income and receive free or reduced lunch
Special Education: 4.% of the students receive special education services, with the majority of services needs being speech and language

The District's Chronic Absenteeism for 'All Students' was considered high at 18.5% which is a 12.9% decrease from the previous year. Socioeconomically Disadvantaged students Chronic Absenteeism rates considered high at 19.6%. Our Hispanic subgroup was chronically absent 23.3% although that declined by 20.8% from the previous year. The district employs six full-time teachers. Five are regular education combination classroom teachers with one being a Resource Specialist Program (RSP) teacher. The 1/2 and 3/4 combination classroom teachers have the assistance of a 4.5-hour paraprofessional in the mornings to assist with core subjects of Math and ELA. The RSP teacher has a 6-hour paraprofessional to assist with interventions. After analyzing state and local data and input from staff and educational partners, we identified various focus areas.

Our vision includes the following: "To challenge each student to reach his or her full intellectual, creative and physical potential, by giving them the skills they need for success in high school, college and beyond. Our students will leave McKittrick Elementary School with the ability and desire to learn about any subject of interest to them. At McKittrick Elementary School, we will provide every student with a safe, orderly, caring learning environment. Additionally, we will offer a fully integrated curriculum and incorporate both academics and a rich, hands-on learning process. This provides our students with both intellectual knowledge and practical knowledge."

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The district's analysis of the 2023 Dashboard did not include any student groups receiving the lowest performance level (Red) on any indicators.

An analysis of the most current 2024 Dashboard shows the following overall performance on state indicators included on the Dashboard.

ELA: 11.6 points below standard- Declined performance (-19.7) (Orange Performance Level)

Math: 23.8 points below standard- Declined performance (-30.1) (Yellow Performance Level)

English Learner Progress: No performance level due to low EL student count.

Science: 10.9 points below standard- Improved performance (+0.8).

Chronic Absenteeism: 21.1%-Increased (+2.6%) (Red Performance Level)

Suspension Rate increased 1.4%- (+1.1%) (Green Performance Level)

Although there was a drop in ELA and Math scores, McKittrick students are performing well above the State average. The state average for Math was -47.6 points below standard. The state average for ELA was -13.2 points below standard. McKittrick scores were exceptional in comparison to the state performance average results.

McKittrick School District will continue to focus on making efforts towards high levels of achievement in order to create a culture of pupil success.

Learning Recovery Emergency Block Grant (LREBG)

The district has unexpended LREBG funds for the 2025-26 school year which can be found in Goal 1 Action 2: Curriculum Training. Our needs assessment revealed significant needs regarding Chronic Absenteeism among the White student group. In response, Goal 1 Action 2 focuses on differentiating instruction to improve access to rigorous instruction for every student. Students who struggle with access to grade-level content often experience frustration and disconnection, contributing to chronic absenteeism (Attendance Works, 2020).

By equipping teachers with tools like tiered assignments and flexible grouping, the district ensures all students can experience success, leading to increased self-efficacy and a greater likelihood of consistent attendance.

Research indicates that when instruction is personalized and meets students' readiness levels, interests, and learning profiles, students are more engaged and invested in their learning (Tomlinson, 2014). Differentiated instruction promotes relevance and autonomy, both of which are associated with improved student motivation and reduced absenteeism. Strategies like choice boards and interest centers allow students to pursue learning in ways that feel meaningful to them, which can increase their sense of belonging and decrease the likelihood of disengagement-related absences.

The action is aligned with LREBG allowable fund uses in the area of: Accelerating progress to close learning gaps through the enhancement of learning supports, such as integrating pupil supports to address barriers to learning. Effectiveness of this action will be monitored through the use of Metric 2.5 Chronic Absenteeism Rate.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Educational partner input, gathered through staff meetings, parent committee meetings, student surveys, and community events, directly influenced the continuation and enhancement of several actions in the adopted LCAP. A consistent theme across engagement opportunities

was strong support for summer programming. As a result, the district increased its investment in the Swim and STEM summer school program (Action 1.3) to address student engagement, connectedness, and attendance—particularly for unduplicated pupils. Additionally, survey feedback emphasized the importance of student-staff relationships and a welcoming school culture. In response, leadership coaching and consulting were prioritized to support the development of an inclusive and respectful school environment. These decisions reflect the district’s commitment to aligning goals and resources with the needs and priorities identified by educational partners.

Goal Analysis [2024-25]

All actions in Goal 1 were fully implemented with the district experiencing both successes and challenges throughout the process. Some notable successes and challenges are provided below.

Action 1 Instructional Support- Teachers were sent to KCSOS to receive training that meets the specific grade levels. challenges implementing this action were related to . The Writing program was not found to be as effective as anticipated, so the district will be exploring other options for the upcoming year.

Action 2 Curriculum Training- Training was tailored to the classroom's needs and used across the core subject areas. The strategies included tiered assignments, choice boards, compacting, interest centers/groups, flexible grouping, and learning contracts. The district encountered challenges regularly securing substitute teachers.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 1.2 Curriculum Training had a material difference between budgeted expenditures and estimated actual expenditures. Only one of the two planned professional development sessions was held due to widespread illness at the school site, which led to the cancellation of the second session. No other actions had material differences. Exact amount of differences can be found in the Annual Update Tables.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Action 1.1 Instructional Support and Action 1.2 Curriculum Training had mixed results. On the one hand, the percent of students meeting or exceeding standards improved in both ELA and Math. On the other hand, distance from standard as reported on the CA School Dashboard, decreased 19.7 points in ELA and 30.1 points in Math.

The improvement in the percentage of students meeting or exceeding standards suggests that actions to strengthen instruction, standards implementation, and learning conditions are having a positive effect for some students. However, the decline in DFS indicates that these actions may not be reaching or supporting students who are furthest below grade level. This highlights a need to strengthen targeted interventions and differentiate instruction, particularly for students who are struggling the most. These results suggest that while the Goal 1 actions were partially effective, there is a continued need to:

- Provide more intensive academic support for students below standard,
- Analyze sub-group data to better target resources, and
- Monitor student progress with both percent met and DFS in mind.

Action 1.3 Summer School-Summer School was effective increasing enrollment of unduplicated students (+13%). This action was also effective improving Chronic Absenteeism rates among SED students (-2.9%)

McKittrick solicited educational partners' feedback in group meetings with the Board, the Staff, and Parent & Community members. The District engagement was collected through in-person meetings, virtual meetings, and online surveys. The majority of the meetings, both virtual and in person, were held in conjunction with established meetings. Board meetings and Parent Club meetings were held monthly. Staff meetings were held monthly. Online surveys were administered to the District's students, parents, and staff. Conclusions are drawn from the feedback show stakeholders find in-person instruction more productive and successful than virtual. Returning to in-person instruction has been difficult. Post-Covid student absences are a problem.

All actions in Goal 1 were fully implemented with the district experiencing both successes and challenges throughout the process. Some notable successes and challenges are provided below.

Action 2.1 Leadership Consultant was hired to mentor the district's superintendent/principal and improve school climate a student connectedness

Action 2.2 Educational Partner Meetings- The district was able to hold 11 Ed partner meetings for the year and 1 dinner to build parent engagement and connection with the school.

Action 2.4 Educational Partner Events- This was the first year the district had 100% participation.

There were no material differences between budgeted expenditures and estimated actuals for actions in Goal 2.

Most actions in Goal 2 were effective based on measurable improvements in parent engagement, communication, student behavior, and perceptions of safety and respect. Although chronic absenteeism increased overall, the notable decrease among socioeconomically disadvantaged students suggests targeted efforts were effective for that subgroup. These results indicate the district is making strong progress in fostering a collaborative and inclusive school environment.

Although Goal 2 included several actions intended to increase engagement and reduce absenteeism, chronic absenteeism rose by 2.6 percentage points overall. While the district made strong efforts to increase parent involvement and improve school climate, actions such as leadership coaching and family events may not have been sufficient to address the complex, post-pandemic challenges contributing to student absences. This suggests the need for more targeted strategies, such as direct student support, attendance incentives, or home outreach, to complement existing efforts. Additionally, the district will investigate how it is tracking independent study to ensure it is not inaccurately contributing to chronic absenteeism rates.

Note that the LCFF Base Grant for purposes of the LCAP also includes the Necessary Small Schools and Economic Recovery Target allowances for school districts, and County Operations Grant for COEs. - **10. Total Percentage to Increase or Improve Services for the Current School Year:** This percentage will not be entered. The percentage is calculated based on the amounts of the Estimated Actual LCFF Base Grant (9) and the Estimated Actual LCFF Supplemental and/or Concentration Grants (6), pursuant to 5 CCR Section 15496(a)(8), plus the LCFF Carryover – Percentage from the prior year. This is the percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all students in the current LCAP year.

Calculations in the Action Tables

To reduce the duplication of effort of LEAs, the Action Tables include functionality such as pre-population of fields and cells based on the information provided in the Data Entry Table, the Annual Update Summary Table, and the Contributing Actions Table. For transparency, the functionality and calculations used are provided below.

- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

- **5. Total Planned Percentage of Improved Services (%)**
 - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
